EXPLAIN THE NATURE OF THE ACTION:

THIS IS A REQUEST TO CHANGE THE HUMAN SERVICES PROGRAM TO INCLUDE AN AS DEGREE PROGRAM WITH AN ADDITIONAL ADDICTIONS CERTIFICATE OFFERED BY EDISON STATE COLLEGE. THE HUMAN SERVICES DEGREE IS LISTED IN THE STATE DEPARTMENT OF EDUCATION FRAMEWORKS AS TWO TRACKS WITH ALL BUT 5 COURSES BEING THE SAME. AT EDISON OUR PROGRAM WILL CONSIST OF 65 CREDITS FOR THE DEGREE WITH AN OPTIONAL ADDITIONAL SIX CREDITS (HUS 2540 AND HUS 2428) TO EARN A CERTIFICATE IN ADDICTIONS. STUDENTS WILL BENEFIT FROM THE DEGREE WITH THE OPTION OF THE CERTIFICATE AS THEY WILL BE CONSOLIDATED INTO A DEGREE PROGRAM. THE CERTIFICATE WILL PROVIDE AN INCENTIVE FOR FURTHER EDUCATION TOWARD ADVANCED DEGREES IN THE ADDICTIONS AREA. THE CERTIFICATE IS NOT A STAND-ALONE CERTIFICATE BUT MUST ACCOMPANY THE AS DEGREE IN HUMAN SERVICES.

PROVIDE JUSTIFICATION FOR CURRICULUM ACTION (OTHER EXPLANATORY INFORMATION):

THIS IS A REQUEST FOR APPROVAL TO SEPARATE THE ADDICTIONS COURSES IN THE HUMAN SERVICES PROGRAM SO THAT THE HUMAN SERVICES PROGRAM WILL CONSIST OF THE GENERAL HUMAN SERVICE CREDITS (TOTAL 65 CREDITS) WITH AN OPTION FOR AN ADDICTIONS CERTIFICATE. THE ADDICTIONS COURSES WILL LEAD STUDENTS TOWARD A CERTIFICATION IN ADDICTIONS AND WILL PROVIDE AN INCENTIVE TO FURTHER THEIR EDUCATION. AT THIS TIME THERE ARE 60 OR FEWER STUDENTS TAKING COURSES IN HUMAN SERVICES. CLARIFYING THE CURRICULUM WILL MAKE IT EASIER FOR STUDENTS. STUDENTS WILL HAVE A CHOICE IN THEIR PROGRAM LENGTH. THE PROGRAM WILL CONSOLIDATE STUDENTS RATHER THAN SPLIT THEM INTO GROUPS WHERE THE ENROLLMENT MAY NOT WARRANT TWO SIMILAR PROGRAMS. THE PROGRAM WILL CONSIST OF 65 CREDITS FOR THE AS IN HUMAN SERVICES. STUDENTS MAY TAKE 6 CREDITS IN ADDICTION COURSES FOR AN ADDICTIONS CERTIFICATE.

NOTE:

CHANGES FOR THE UPCOMING FALL TERM MUST BE SUBMITTED AND APPROVED NO LATER THAN THE FEBRUARY CURRICULUM COMMITTEE MEETING PRIOR TO THE START OF THE NEXT ACADEMIC YEAR. CHANGES DURING MID-SCHOOL YEAR ARE NOT ALLOWED. EXTREME CIRCUMSTANCES WILL REQUIRE APPROVAL FROM THE DISTRICT DEAN OF INSTRUCTION AS WELL AS THE VICE PRESIDENT OF ACADEMIC AFFAIRS TO BEGIN IN THE SPRING TERM. THE PROPOSED CHANGES MUST BE PRESENTED AND APPROVED BY THE SEPTEMBER CURRICULUM COMMITTEE PRIOR TO THE SPRING SEMESTER.
