

## **Collection Development Report of Criminal Justice Sources in the Rush Library at Edison State College**

This collection development plan is concerned with the HV Criminal Justice materials at the Rush Library of the Edison State College in Fort Myers, Florida. The college offers undergraduate degrees in criminal justice, with a special emphasis in crime scene technology. A professional collection of criminal justice books should not only be current, but also reflective of the curriculum and research interests of faculty and students at the college. This point is made clear in the Library Policy Manual Rule VI.

### **Weeding**

An important aspect of any library collection is to “weed” it now and then. Criminal Justice is an ever evolving field. Research and theories held true thirty years ago may no longer be accurate or in-line with current trends and practices. Therefore, criminal justice materials should be weeded according to established rules contained in the Edison Library Rules. Rule VII is concerned with weeding. Books should be weeded if the following criteria are met: “accuracy and currency of information” or “appearance or condition.” The following Weed List are materials that should be removed from the HV Criminal Justice collection.

1. Kenney, J. P. (1965). *Police Work With Juveniles*. **HV9069.K43** This book is very out-of-date. Police work with juveniles today is very different than in 1965.
2. Vedder, C. B. (1963). *Juvenile Offenders*. **HV9104 .V4** Another book that is out-of-date.

3. Sherman, L. (1978). *The Quality of Police Education*. **HV7923 .S53** Book has a faded cover and is not current with recent changes in police education.
4. Klotter, J. C. (1963). *Techniques for Police Instruction*. **HV7923 .K55** Police instruction has changed since 1963.
5. Harrison, L. (1964). *How to Teach Police Subjects*. **HV7923 .H3** Another out-of-date police training book.
6. Carter, R. M. (1970). *Probation and Parole*. **HV9278 .C28 1970** Someone wrote in this book and has a faded cover. Also research is out-of-date.
7. Mitford, J. (1973). *Kind and Usual Punishment: The Prison Business*. **HV9471 .M58** Book is not in line with current social changes in prisons.
8. Schultz, D. O. (1977). *Crime Scene Investigations*. **HV8073 .S345** Crime scene technology has changed a lot since 1977.
9. Morland, N. (1958). *Science in Crime Detection*. **HV8073 .M782** Another antiquated book on crime scene technology.
10. Kilinger, G. (1973). *Penology*. **HV9304 .K54** This book is in bad condition and is not in-line with current correctional trends and research.
11. Bennett, I. (1960). *Delinquent and Neurotic Children*. **HV9069 .B54** Psychology and juvenile justice have changed since 1960.
12. Garbedian, P. G. (1970). *Becoming Delinquent*. **HV9104 .G33** Book is in bad condition and not in-line with current trends and research.
13. Otley, E. M. (1985). *Adolescent Sex Offenders*. **HV9104 .A64 1985** Book is in poor condition and full of out-dated phone numbers and addresses.
14. Bopp, W. (1970). *Police-Community Relationships*. **HV7936.P8 B65** Outdated book that uses vernacular terms like "Negro Community."
15. Revere, V. (1982). *Applied Research for Criminal Justice Professionals*. **HV6789 .R42** Book has a broken binding.
16. Stuart, H. (1928). *Notorious Ashley Gang*. **HV6452.F421 S7** This old book probably belongs in a special collection.
17. Guze, S. (1976). *Criminality and Psychiatric Disorders*. **HV6133 .G88** Psychiatry has changed since 1976.

**HV9475.C3 S7317** Book does not reflect the current plight of Hispanics in San Quentin.

## Famous American Crime & Criminals

**Gary Gilmore:** First man to be executed for murder after US Supreme Court reinstated the death penalty in the late 1970s.

**Charles Guiteau:** Assassin of President James A Garfield in 1881. Guiteau tried to argue his own insanity.

**Dan White & The Twinkie Defense:** Disgruntled city politician assassinates the mayor of San Francisco and councilman Harvey Milk. White argued Twinkies made him do it.

**Richard Ramirez the Night Stalker:** Devil worshipping serial killer goes on a killing spree in 1980s California.

**Charles Whitman:** Infamous "Tower Sniper" at the University of Texas in the mid 1960s. Whitman killed several faculty and students before police killed him.

**John Hinckley:** Attempted assassin of President Reagan. Tried to kill him to get the attention of actress Jodie Foster.

**Mark David Chapman:** Man who killed John Lennon out of jealousy.

**Ted Bundy:** Famous American serial killer known for murdering women.

**Jeffrey Dahmer:** Famous serial killer and cannibal.

**John Wayne Gacy:** Chicago serial killer who murdered male prostitutes.

**Sam Berkowitz "Son of Sam":** Killed several people in New York in 1977.

**Dennis Rader:** Infamous BTK (Bind-Torture-Kill) serial killer in Kansas.

**Karla Faye Tucker:** Famous death row inmate who found God while awaiting execution.

**Lindberg Kidnapping:** Noted aviator Charles Lindberg's child was kidnapped by German immigrant Hauptman. Trial was circus-like.

**O. J. Simpson:** Former NFL star and was acquitted of murdering his ex-wife Nicole Simpson and Ron Goldman.

**Eileen Wournos:** Female serial killer who murdered several Johns in Florida.

**Bernard Goetz:** Subway Vigilante who shot some perceived gang-bangers who asked him for money.

**Lizzy Borden:** 19th Century spinster who murdered her parents.

**Al Capone:** Italian-American gangster who controlled Chicago's bootlegging in 1920s.

**Johnny Dillinger the Public Enemy:** Notorious Depression-era bank robber.

**Caryl Chessman:** Red Light Bandit who was accused of serial rapes. Defended himself at trial and became a celebrity in 1950s.

**Charles Manson:** Masterminded the Tate and LaBianca murders in 1960s California.

**John Wilkes Booth:** Assassin of President Abraham Lincoln.

**Emmett Till Murder:** Two white men murdered Emmett Till because he whistled at a white women. Murder sparked the Civil Rights Movement.

**Dr. Sam Shepard:** Wrongfully accused physician acquitted of murdering his family. The murders inspired a TV series *The Fugitive* in the 1960s.

**Leo Frank Lynching:** Jewish-American businessman Frank was railroaded into a conviction for the murder of Mary Phagan. When the governor tried to help him a lynch mob hung Frank.

**Richard Speck:** Notorious serial killer who murdered several women in a college dorm.

**Bonnie & Clyde:** Famous bank-robbers during the Great Depression.

**Albert DeSalvo:** The Boston Strangler. Accused of murdering several women.

**Jesse James:** Infamous bank robber in 19<sup>th</sup> Century Missouri.

**Menendez Brothers:** Eric and Lyle Menendez murder their rich parents and claim it was self defense due to years of sexual abuse by their father.
