One member voiced concern over dropping three of the five general education outcomes (especially quantitative reasoning, QR), and Professor Walters explained that it was done on the advice of SACS as well as feedback from the instructors. The chair added that while this course could cover two, the capstone course could cover all five. Dean Rath and Professor Walters also noted that while QR is not in the syllabus outcomes and assessments, it is in the course, for example, in financial planning.

Harrell's office. I have reviewed the syllabi for NUR 1010 macology and Math Calculations. Their prerequisites II with a letter grade of "C" or higher; acceptance into the

This is a follow up to our conversation last Wednesday in Dr Harrell's office. I have reviewed the syllabi for NUR 1010 Introduction to Nursing and NUR 1142 Introduction to Pharmacology and Math Calculations. Their prerequisites statement is "BSC 1093C,MAC 1105 or higher or STA 2023 all with a letter grade of "C" or higher; acceptance into the nursing program". The current language in the NUR 1060/1060L prerequisite statement is not acceptable (different requirements for day and evening students). Since NUR 1060/1060L is now available to be taken in the first semester of the basic program like NUR 1010 and NUR1142, I believe it would be best if its prerequisites statement was the same as NUR 1010 and NUR 1142.

In response to Judi's questions related to NUR 2260 and NUR 2206L, it was my intention that the prerequisite statement for NUR2260 remain the same except for the addition of HUN 1201 as a prerequisite. It was an error on my part not to change the default grade for the prerequisite from "D" to "C". It is the policy of the nursing program not to accept any course with a letter grade lower than a "C". To be honest, at this point I don't know why I put to remove them from the NUR 2260L syllabus. I guess I just got lost in all the changing.

I am happy to work with you and Dr Grove in person to iron all this out. I'm available on Wednesday morning and on Thursday this week.
