- Introduction of Committee members
 - Deb Johnson introduced herself to the committee
- Documents Uploaded to Canvas
 - Minutes from the 1st meeting. Asked for corrections/comments.
 - Mission statement
 - Edison Online College Operating Procedures:
 - Initial Faculty Certification
 - New Course Development
 - Enhancing Ground Courses
 - Renewal Faculty Certification
- Need to upload documents to Canvas

 - Both courses have been through complete QM cycle
 - Instructors used feedback to improve courses
 - Need to check latest success rates in these courses
 - Fall 2010 – ENC1101
 - Course went through redesign
 - Feedback was distributed to all those working on course redesign
 - Exams are pulled from testbank
 - eStudio assessments are good
 - online assessments are not
 - Ellie asked for someone to review the assessments, she experienced low test scores in the online class
 - Spring 2011 – BSC 1010
 - Need to follow up with Randy and Peggy

- Peggy needs to complete the faculty response form
 - Several requests have been made, no response thus far
 - Spring 2011 – Adjunct Self-Evaluation
 - Completed as part of the e-Portfolio process, adjuncts were asked to conduct a QM Self-Evaluation
 - Most took the exercise seriously
 - Last meeting we recommended implementation of computer/technical literacy modules and assessment of student’s readiness for online learning.
 - **LRSC** - Learning Resources Standing Committee of the Council on Instructional Affairs (FL DOE) is creating the modules and will make them available.
 - **Update:** It was recommended that the computer literacy modules be incorporated into the FYE curriculum. Rona contacted Myra Walters regarding the recommendation, waiting to hear back.
 - **Issues:** Can we make the assessments mandatory in the online program? Can instructors incorporate the assessment/modules into their syllabi?
 - 2006 and 2011 (draft) documents have been uploaded to the canvas course
- **Background/Future of Learning Management System**
 - Committee wants to know student perceptions of Canvas/Blackboard
 - **UPDATE FROM DOBIN:** Yes – very positive towards Canvas, not as much towards Blackboard. The information will be uploaded shortly to the “Why Canvas” course that explains our entire process.
 - Will the blended courses and CE6 enhanced courses be brought over to new LMS?
 - **UPDATE FROM DOBIN:** Eventually, but Online will be the first to move along with the FYE classes because we wanted them to experience the new system as they come in and not CE6. Officially, EOL is paying the full price for the system until the fall, so we will concentrate on blended and ground courses starting this summer.

- **Evaluation of course design**
 - Created discussion in canvas
 - Will start to solicit feedback from committee regarding current process (QM)
