President's Report

- The Florida Senate Education Committee and the House Higher Education and Workforce Subcommittee have approved the renaming of Edison State College to Florida SouthWestern State College.
- On January 23, Edison was named as one of 15 Florida colleges eligible
 to compete for the prestigious Aspen Prize for Community College
 Excellence based on exceptional levels of student success in three areas:
 student persistence, completion and transfer; gains in outcomes over time;
 and equity in outcomes for underserved students.
- The Yoko Ono Peace Exhibit opened on January 24 with over 800 people attending. The exhibit continues through March 29.

- Edison State College alumnus Daro Kurdson was one of 11 students throughout the United States to receive the Sigma Beta Delta International Fellowship award for 2013. Every year, the Sigma Beta Delta International Honor Society for Business, Management and Administration selects 11 students from its more than 375 national and three international chapters.
- Hendry/Glades Center alumna Crystal Gomez was recently selected as the Florida College System Chancellor's Student of the Month for exceptional leadership skills, academic success and community service.
- Jill DelRio, an Edison State alumna and Oak Hammock Middle School teacher, was the first recipient of the "Educator of the Month" award which also advances her as a finalist to become the "Top Educator of the Year."
- The Athletic Task Force met in December regarding the search for a
 Director of Intercollegiate Activities. The search committee was headed by
 Dr. Jeff Stewart, Vice President, Research, Technology & Accountability.
