2. Review of Discussion: Designation of AA courses: Dr. Wright The discussion about what constituted an AA course and how were AA courses so designated was carried over from the February meeting. P. Romeo and R. Smith had a meeting with the VPAA and Provost, Dr. Wright.

A March 31st memo from P. Romeo detailed the outcome:

- Do we really need the AS distinction other than as a means to signify
 the course cannot be counted as an AA elective? Yes, if the course is
 an AA, then it is also AS. But not the other way around. So, if not
 designated, course is both, but if we do not want it to be AA, then it
 must say AS. We can designate in catalog that "this course cannot be
 counted toward your AA degree."
- Can a course be designated as both AA and AS? Explained in above statement.
- What role should the Gen. Ed. competencies play? Some of the AS courses we looked at show the course is meeting all 5 of the current Gen. Ed. competencies? None..... not to be considered.
- Should our current Gen. Ed. competencies be reexamined for all courses? Or is that happening now? If so, are we doing this Workforce Course task prematurely? They are currently being looked at for change, but doesn't make a difference for our choice.
- Can we ask for individual courses to be defended? That is, can we ask
 the Chair or program coordinator, in conjunction with their faculty to
 make a case for why a course previously designated as AS should be
 considered as an AA elective? Yes
- Once a course is changed from AS to AA elective, can any student take
 the course, or only those enrolled or accepted into a particular
 program? Yes, but may be subject to the program and therefore stated
 in the catalog something along the line that only students admitted
 into the program may enroll in the course. This would be up to the
 program coordinator along with faculty teaching for the program.

3.	Workforce Petition for AA courses	Relating to General Competencies, E. DeLuca said the implementation for the general core course options is 2015-2016 There is currently a General Education Committee led by Dr. Laura Weir that is working on the implementation plan. That team may suggest changes for the current General Education competencies. She also mentioned that there is a one-year "moratorium" on new four-year degrees in the State Colleges. The committee members concluded that the push for AA designations might slow due to the moratorium. C. Gilfert said that her experience is that some AA students would favor any effort by the College to convert AS to AA/AS so that they could count these as electives. A course that is often mentioned is the AS course in <i>Marketing</i> . She continued that a program area need NOT
