Hi Dr. Collins,

I can provide you with some background information, but you will have to contact Michelle for any changes to curriculum for 2014-2015.

(For the current HUS 2551):

- Dr. Mary Lewis initially numbered the proposed course as HUS 2310. Then she changed the number to HUS 2420
 and changed the title when she presented it at the Curriculum Committee meeting in Feb. 2011. The 2010-2011
 catalog listed HUS 2420 (core course) as pending Curriculum Committee approval for the AS Human Services
 degree program.
- 2. SCNS (Judy Yancey) re-numbered HUS 2420 and approved the course as HUS 2551—see the notes on the bottom of the SCNS page (screen shot). Dr. Mary Lewis agreed to the number assigned by SCNS in March 2011 instead of appealing. Dr. Lewis also proposed a Certificate in Addictions Studies in March 2011, effective Fall 2012, which was discontinued in Feb. 2012 before it was scheduled to start in Fall 2012. The 2 courses she was going to have in the Addictions Certificate were HUS 2540 and HUS 2428.
- 3. When FSW submitted HUS 1551, and SCNS objected, due to the College already having HUS 2551, the School's decision in May 2014 was to use HUS 2551 in the AS Human Service Generalist program in lieu of the proposed HUS 1551; HUS 2551 had already been included in the AS Human Services Addictions track in 2 places—as both elective and core.
- 4. Judy Yancey retired on Sept 11th (last week). I do not know who is replacing her for Human Services.

Hope this helps.

Hi Marie,

Professor Erwin has discovered a problem with one of our courses and I don't know what procedure to utilize to make the correction. I'm also not sure how this happened, other than to say that it may have been something that was on the old format from a long time ago and I didn't catch it.

We have not offered the course HUS 2551 yet. Terry Erwin is planning the course to be ready for Spring, 2015. She found a professor at another college teaching what she thought was the same course, but upon closer examination and collaboration, discovered that it is not the same course.

The course in question is one that that we have named HUS 2551 is titled "Evaluation of Treatment Environments". However, this is the wrong title and description. The curriculum committee approved this in March, 2014. If you recall, I had tried to pass HUS 1551, but the curriculum committee had decided not to approve this since we already had HUS 2551 on the list. The problem is that the course name was incorrect the whole time.

According to the State Numbering System, HUS 551 is titled "Multicultural Perspectives in Human Services". http://scns.fldoe.org/scns/public/pb course dtl.jsp

So, as a result of the name scramble, the course title is incorrect and the course description is incorrect and the syllabus template is incorrect. What we want to do is to keep the course number as "HUS 2551", but change the title of the course to "Multicultural Perspectives in Human Services" and change the course description.

May we ask the VPAA to help us by approving this change/oversight or do we have to go back through the curriculum committee? I'm copying Dr. Erwin on this to be sure that I have represented this issue accurately. Below are previous email correspondence regarding the issue for your review.

Thank you for your note and your sharp eyes.

The courses will be slightly different. With the recent approval of our two tracks in the Human Services Associate of Science Degree Program, a division was made with the primarily addiction focused courses and the "general" courses.

The following is a summary of my intentions:

HUS 2551 is listed as a course for the Addictions Track. The intention is to focus on the multicultural diversity considerations with regards to alcohol and drug abuse treatment in this course. Different cultures/religions/races, etc. approach alcohol and drug use/abuse differently, and some are more vulnerable than others. Thus, interventions such as counseling, support, family work, etc. is very different in the field of addictions counseling. This course has prerequisites attached related to the addictions field, thus the advanced designation.

HUS 1551 is the newly proposed course for the newly formed "Generalist" Track. This course is intended to be a broader focus on diversity in counseling and human services across the service spectrum. Approaches to counseling and social work, parenting assistance, financial aid, housing, career services, healthcare, etc. will be reviewed regarding the human services field.

Hi Michelle and Stacey,

HUS 1551 has been RETURNED to Edison by SCNS because Edison has a course HUS 2551, and they consider 1551 and 2551 as the same--only 2551 is at a higher level.

When HUS 2551 was initially submitted to SCNS in 2011, we submitted it as HUS 2420 but Judy Yancey (SCNS) changed it to HUS 2551 and Dr. Mary Lewis agreed.

The course descriptions from Curriculum Committee proposals are as follows:

HUS 2551—Evaluation of the Treatment Environment

This course is designed to give students an in-depth understanding of forces that impact minority and other disenfranchised families in America. Emphasis will be given to historical trends, social stratification, and current status. Additionally, the effects of perceptions and misconceptions on minority and other disenfranchised families will be considered. The primary purpose of this course is to prepare professionals to work effectively with individuals who are ethnically, culturally, and racially different.

HUS 1551—Multicultural Perspectives in Human Services

THIS COURSE addresses cultural diversity and its implications for effective counseling and human service practice. it considers the psychological impact of factors such as sex, race, ethnicity and culture, religious preference, socioeconomic status, sexual orientation and physical disability. Common stereotypes and outgroup prejudices and how to overcome them in counseling. A review of counseling issues and strategies for diverse clients will be provided.
