The Chair also proposed a possible change in wording to item 6 on page 4 from <i>endorsed</i> to <i>reviewed</i> which would result in a revision of all Curriculum Committee forms to reflect the removal of the Dean's Council Representative as a necessary step for endorsement if approved. An additional change was proposed from the floor to revise the title for the representative from the Deans to <i>A Dean Representative</i> . And, finally, the Chair opened the floor for discussion of the topic of representation of campuses on the Committee since there is currently no full-time faculty representation from the Charlotte campus.
