# 4. Program review of the AA degree & General Education Program:

Attachment #2 Discussion Item (Presenter: Dr. Wright & Dr. DeLuca)

Dr. Wright and Dr. DeLuca provided an overview of the General Education assessment program. Dr. DeLuca addressed the difficulty in evaluating and tracking the outcomes in the General Education and AA programs. Dr. DeLuca gathered input from the faculty and Deans and piloted a model survey from AACU last year; it is still a work in progress. Work is being done on value added studies for next year. Updates to be provided in the future.

### 5. Prospective Bachelor degrees:

Dr. Wright announced that the State lifted the moratorium. Additionally, he discussed his intent to submit a proposal for a new Computer Information Technology degree. To initiate the proposal, Dr. Wright indicated that a letter of intent would be forthcoming in the fall of 2016. He expressed that the degree would complement the needs of our small-local businesses. Discussion was held on other potential degree offerings.

#### 6. Career Services Agreement:

Dr. Davis discussed our newly signed MOU with Career Source of Southwest Florida. They offer a variety of career counseling services to our students such as, resume writing, creating cover letters, and interviewing techniques. A career counselor is available on the Lee campus for 24 hours per week and Collier campus for 16 hours per week.

#### 7. Profile of housing residents:

Dr. Davis presented data regarding the Lighthouse Commons residents for fall 2015. The data included information on Florida residents and non-Florida residents, as well as data broken down by county. The demographics tend to match the general college population.

#### 8. Strategic Enrollment Management:

Dr. Davis discussed the college's enrollment report and the respective campus enrollment trends as they relate to total FTE and headcount.
