<b>TYPE OF PROPOSAL</b>	New Course
<b>PRESENTER</b>	Natala Orobello
<b>Summary of proposed changes:</b>	
<p>The School of Arts, Humanities, and Social Sciences proposes a new 3 credit course, <b>LIT 2383 Women's Studies in Literature</b>. The course introduces students to the affect (influence) and effect (the result) of Women's Literature as it is written for women's equal rights. Students will review, analyze, and assess chosen literary pieces within a chosen text (decided by individual professors) and supplemental material in order to more clearly understand how specific literary genres changed and continue to change the feminist movement. Effective date is Fall, 2016.</p>

<b>Summary of proposed changes:</b>	
<p>The School of Pure and Applied Sciences proposes a new 4 credit/5 contact hour course, <b>BSC 1085C Anatomy and Physiology I</b>. The course is part one of a two-semester course in Anatomy and Physiology primarily intended for health science majors. This is an inquiry based lecture and lab integrated course and includes investigation on the structure and function of human systems including integumentary, skeletal, muscular, nervous and special senses. It is recommended that students complete BSC1010 and BSC1010L prior to taking this course. Effective date is Fall, 2016. The course is being proposed as a Core General Education course.</p>

<b>Summary of proposed changes:</b>	
<p>The School of Pure and Applied Sciences proposes a new 4 credit/5 contact hour course, <b>BSC 1086C Anatomy and Physiology II</b>. The course is part two of a two-semester course in Anatomy and Physiology primarily intended for health science majors, designed to be the sequel to BSC 1085C. This combined lecture/lab course covers the following topics: endocrine system, cardiovascular system, lymphatic and</p>	

immune systems, respiratory system, digestive system, nutrition, urinary system, fluids, electrolytes, acid-base balance, reproduction, growth and development. Effective date is Fall, 2016. The course is being proposed as a Core General Education course.

The new CCC requires a reduction in total course hours from 39 credits to 24 credits. Effective date is Fall, 2016.

The new degree requires a reduction in total course hours from 65 credits to 60 credits. Effective date is Fall, 2016.
