ALL FINANCIAL AID RECIPIENTS

If you are planning on using your financial aid (grants, loans, scholarships) for the upcoming Spring semester (Full, A and/or B term), you must finalize your enrollment by the **Add courses, change credit/audit, change degree status** deadline.

This means that you **MUST** be enrolled in all of the courses you want considered for financial aid funding by **January 11th, 2017**.
