<p>This course is scheduled for deletion from the catalog due to 5-year inactivity.</p> <p>SoBT has deliberately created program-specific internship courses for each discipline represented in the School. This course is the second-level internship experience for civil engineering and for construction technology. While the course has not had enrollment, it is always available to students.</p> <p>Given the increasing focus on internship activity as both an educational and placement tool, the faculty would like to see the internship opportunity remain available. Lastly, the SoBT Advisory Committee continues to stress the importance of internships.</p>


