President's Report

- Dr. Allbritten recognized Byron Donalds for his service on the Board from 2014 through 2016, and presented him with a plaque.
- Brian Chapman summarized his 01/11/2017 meeting with Governor Rick Scott and the Board of Trustees' Chairs from the Florida College System, and shared a handout.
- Brian Chapman suggested securing a Board Attorney. The intent is to have an attorney available for hire if necessary. Chris Vernon will report back after calling the college who has a Board attorney.
- Dr. Allbritten shared FSW's one-page response to Governor Scott's three initiatives: Finish
 in Four, Save More; Becoming #1 in Performance Funding Metrics; and, Best Practice
 Implementation. He emphasized the importance of communicating with the Governor and
 urged all Trustees to do so.
- Mrs. Starnes-Bilotti requested that John Meyer, Dean, School of Business and Technology, speak at the next meeting regarding a future focus on graduate employment.
- Dr. Allbritten gave an overview of SB374 Excellence in Higher Education, and SB2 Performance Funding.
- Both the men and women's basketball teams are bound for the NJCAA State tournament next week in Ocala, FL.

- Our Suncoast Arena is the #1 building in the state with the presentation to Harvard Jolly of the Florida Educational Facility Planners Association (FEFPA) 2017 Architectural Showcase First Place Award for College Category.
- In 2013, Dr. Thep Ayudhya, Professor, Chemistry, in collaboration with Dr. Nin Dingra, Director, Faculty and Student Research, began researching the use of organic boron compounds as a drug delivery system to defeat various diseases. They have successfully filed a patent for their project, and it is now patent-pending.
- Dr. Allbritten noted meeting with the Lee County Commission for help from the Tourist Development Council for the Barbara B. Mann Performing Arts Hall as he had mentioned earlier to the Board members.
- The Schulze Family Foundation presented a \$300,000 gift to the FSW Foundation for student scholarships to be divided equally between the School of Education and the School of Health Professions and awarded to students in the Early Childhood Education program and the Nursing program over the next three years.
