- 3. Simulation Education Plan A new funds to establish an operational budget; Plan B SWFL Children's Charities Fund.
- 4. Simulation Education Lynne reports over 4000 hours of use on Lee campus. Increased use at Lee. She is not sure about use on Collier and Charlotte campuses. Scheduling seems to be working well for all programs represented today.
