#### Financial Aid:

Kristen Zimmerman shared information about Financial Aid. She recently met with Cindy Lewis, Director of Financial Aid. Kristen also brought up the Federally Funded Program – Teach Grant as an option for the Education students.

The Education Department and the University Center may also use the Work Study Program as an option for student assistants. In addition, teacher candidates may be eligible to be paid for their 15 hours of field experience in the Literacy and Reading Programs. Cindy is willing to go thru the rosters to determine the students that would be eligible for Work Study.

Cindy Lewis will be asked to join our next Dept. meeting to clarify some of the Financial Aid questions.

Sue will check to see what the procedure is to hire a Work Study student.
