- Make internships part of the process
 - o Elective credits can be met by internship
- For credit only internships
 - Limited possibilities for paid internships
- Mentorship/internship
 - o Will that fit into internship for credit criteria

Courses underway

- RMI2110 Personal Insurance launching in Spring 2019
- RMI2212 Personal Business & Property Insurance starting summer 2019
- RMI2662 Intro to Risk Management & Insurance starts Fall 2019
- Minimum class size per college is 12
 - o Will initially run with fewer to get program off the ground
- Connect via polycom to attract students from the other campuses that may not want to drive to Lee
- New RMI classes offered as evening classes
 - o Why? Non-traditional student
 - o Online/blended classes
- Guest speakers
 - o Email blast to advisory group for guest speakers based on particular topic
 - o Get students excited about industry
 - Other aspects besides money
 - Community service
- A suggestion for at least one class be a mandatory online class was made
 - o Agents need to be comfortable with heavy computer use

Other recruitment ideas (news story)

- Board members can reach out to their own networks to spread the word and bring additional students in
- Horizon council?
- General insurance companies
 - o Can't afford licenses?
- Recruit from high schools
 - Get program info to guidance counselors
- Veterans groups
- Hispanic chamber of commerce
 - o Spanish speaking agents desperately needed
 - o Potentially could make more money
- Invite students in program/prospective students to program to "speed dating" type interview process
 - Spend 5 to 10 minutes with members of advisory board
 - o Gives students practice before they hit the job market

- Gives board members a chance to pre-screen potential candidates for internships, mentorships, jobs
- Board members with contacts in local media asked to reach out to suggest a news story to promote new program

Other

- FAIA provided \$5000 to each school to use as they see fit to promote the program
- Dr. Psihountas would like to use the money to provide small scholarships to students who sign up for the program
 - o \$200 scholarship will partially pay for 1st class
- Is there other money out there? Other suggestions were asked for
- Guarantee an interview/job after finish program by members of advisory board
 - o Exclusive for advisory board
 - Within a specified time-frame
