### Dr. Psihountas Updates:

- According to Institutional Research, using fall 2018 data, 50% pf the highest DWF courses college-wide are from SoBT. The problem is not unique to us, but it is complicated to solve this issue

- It was commented that one problem is that faculty must enter the first day attended if giving an "F" grade even if the student was never in class and did not drop the class.

# **Final Comments:**

- A discussion ensued regarding the Student Opinion Surveys. Ground courses no longer have the paper survey option so how do we get the students to complete the electronic survey? If students are not getting points for completing the survey, they just do not submit it.
   We are able to add up to 3 questions of our choosing to the survey and it was suggested maybe the questions could include what went well and areas of improvement of the course. The questions would be voted on by the faculty whether to be included or not. Can we do surveys on our own? At this point, it was suggested by a department chair that they look into whether this is possible with the union first.
- Compliance assist It was commented by Institutional Research that some SoBT programs have too much assessment data and others have too little data.
- Another conversation about the SOS included the following comments: If one student from the class complains, what about the rest of the class and they feel like the instructor is guilty before an investigation of a complaint has been completed.
- Overload limits is an economic issue where some faculty need to teach overloads. It was commented that adjunct faculty have full time jobs and they are able to teach up to four courses per semester.

Dr. Psihountas thanked all for attending and the meeting was adjourned to the breakout meetings at 2:30 p.m.

### COMPUTER BREAKOUT MEETING FRIDAY, APRIL 12, 2019 2:30 PM - 3:15 PM

In attendance: Dr. George Kodsey, Deb Johnson, Vinnie Butler, Barb Perrine, Dr. Psihountas, Associate Dean Baker, Kathy Fanny, and Mary Conwell, J.D.-Interim Chair - FSW Computer Studies Program

**Open Educational Resources:** Open Educational Resources are not often used in computer studies classes, but when they are used, there can be a problem with professors still using supplemental materials from previous textbooks, which is copyright infringement.

**Canvas Rubrics:** Professors in some online classes are not recording data in the provided Canvas rubrics. Professors need to record in the Canvas rubrics even if they know the rubrics well and use them as a guide for grading. Another problem with online classes is the lack of student-professor engagement. For example, some professors do not respond to email, and some students do not respond to email. Dr. Van Gaalen is hosting a mandatory workshop for both full-time and adjunct faculty in August 2019 on exactly what is needed to ensure the goal of a uniform and accurate system of assessment.

**Interim Chair Situation:** Two new faculty will be hired as full-time computer studies professors this spring. It has been proposed that one of these new hires become the permanent chair of the computer studies program. However, there are issues involving a new professor who is not on continuing contract filling the role of a department chair.

**Textbook adoption**: There is little or no course development planned because there is no money to pay faculty to develop master classes and master course shells. There may be no uniformity in the course shells going forward. However, Quality Matters training will be taught by Anita Rose for online professors. When the college pays someone to develop an online course, the developer does not own the course, eliminating copyright issues.

**Good website:** Interim Chair Conwell recommended the website noredink.com to assist students with written communication problems.

**Project by Dr Kodsey**: He is working on research to study behavior that is not easy to measure. Presently he is collecting information from students and faculty to input using software. It is a mathematical model. It is a huge undertaking, but he hopes to get support.

**Student Food Insecurity:** It is estimated that 60% of students at community and commuter colleges will experience problems with food, housing, and/or transportation at some point during their studies in college. There are current and former FSW students who are homeless and living in their cars or wooded areas in Southwest Florida. Many students live on the edge. Faculty should look into establishing a college food pantry on campus. Associate Dean Jennifer Baker spoke about a program at FGCU which partnered with Harry Chapin. The problem of student hunger needs to be brought to the attention of FSW's Provost and FSW's student government. Professors are often not aware of the serious life issues facing students. Frequently it is a choice of eating or putting gas in the car to attend a ground class.

Paralegal Studies Breakout Meeting Friday, April 12, 2019 - 12:00 PM – 1:00 PM – U106

**In Attendance:** Matthew Hoffman, Mary Conwell, Michele Gatto, Sandi Towers-Romero, Dr. Psihountas, Jennifer Baker, and Jill De Valk

**Approval of Previous Meeting Minutes:** After a review of the previous meeting's minutes, there was a motion to approve the minutes. The motion was seconded. All approved so the motion carried.

**Cyberlaw Course – Professor Matt Hoffman:** Matt has developed a Cyberlaw course which will debut in the spring 2020 semester. This course will cut across many disciplines including Associate of Arts degree-seeking students.

**Open Education Resources (OER) Issues: Copyright, Accessibility, Peer-Reviewed:** Professor Conwell attended the Textbook Affordability Committee meeting recently. If we are moving toward OER, we need to be cognizant that we cannot use supplemental resources from the former textbook due to copyright laws. The three cornerstones of copyright, accessibility, and peer-reviewed need to be included in the process of developing classes using OER.

**Mandatory Workshop in Fall 2019:** The workshop will include recording in Canvas rubrics, grading online assignments, and enhanced online student-professor interaction and engagement. In the workshop, we will outline clearly what is expected.

Dr. Van Gaalen of Institutional Research discovered that in online courses, some faculty were not using the rubrics. The rubrics in the Canvas shells need to be utilized and recorded. Institutional research drills down to look at individual courses to see if the professor is scoring in the rubric. It was discussed that the rubrics grading procedure was perhaps never communicated to newer professors. Moving forward, scores need to be recorded in the rubrics. One way to grade late assignments in rubrics should be to grade for mastery of content but deduct points in the grade for lateness.

Student-professor engagement can be an issue in communication with online courses. Michele Gatto commented that she gets back to students as soon as possible and if there is no response, will call the student or offer to meet them. She stated that she has experienced students who show up to class but do not submit assignments. She continues to attempt to communicate with them to complete the assignments. It was discussed that communication is a two-way street and that students need to reply.

Engagement with the students depends on the assignment. Currently in Canvas, faculty only receive notifications once a day which is inefficient. Instead of commenting while grading it was suggested to convert the message to email like Canvas messaging. One suggestion was to send an email directly to the faculty member, but then it is impossible to check comments on a phone. Another option would be to tell students to call or text the faculty member.

American Association for Paralegal Education (AAfPE) Regional Conference: Professor Conwell recently attended the AAfPE Regional Conference in Chicago. Discussions at the conference included food insecurity experienced by students and the need for a food pantry at FSW locations. Mary commented that a Houston area college has a pantry open 24/7 with weekend packages available for commuters. Some colleges also have clothing available to students for job interviews. Dress for Success is a local organization here who helps women with business attire and assistance with interviewing skills.

One of the technology sessions included a discussion regarding computer software that is programmed for case briefs, providing cases, and citing and then added to the drop box to send to the agency. Professor Conwell mentioned that she would like to attend the ABA Technology Conference in February 2020 in Chicago in an effort to learn more about the trending technology available.

The legal recruiting session included why an agency should hire an applicant and what applicants should emphasize in their resumes. Employers like interviewees who exude self-confidence and that applicants should memorize their resume so that they are familiar with their work experience. Also mentioned was that applicants often interrupt the interviewer and then end up not answering the original question. Sandi mentioned that she addresses the do's and don'ts of interviewing in the Cornerstone course and in Law Office Management. It was suggested that faculty should include tips in the Intro course and Paralegal Internship orientation such as "do not interrupt interviewer's questions".

Wages were also discussed, with paralegals in the Chicago area starting out from \$40,000 to \$50,000. It was mentioned in the session that Beacon Hill Agency recently placed a paralegal with ten years of trust experience at \$200,000. Intellectual property paralegals can earn up to \$150,000 per year which suggests that specialty area experience helps paralegals earn more.

**Emerging Opportunities for Paralegals:** Selling legal software and training law firms to use the software is an emerging opportunity for paralegals. There are also opportunities for paralegals to freelance in the legal areas of E-discovery, litigation support, legal research, document review and coding, legal billing, and factual research.

**Noredink.com:** An online platform that provides grammar assistance to students. This tool helps students by focusing on the student's weaknesses.

**Upcoming Conferences:** The AAfPE National Conference is this fall 2019 in Detroit, Michigan. The AAfPE Regional Conference will be located in Myrtle Beach, South Carolina in the spring of 2020. The ABA Tech Conference is scheduled for February 2020 in Chicago.

Interim American Bar Association Report: The report is due on July 15, 2019.

**Metrics:** The Office of Institutional Research informed Dr. Psihountas that of the 22 courses with the highest D-W-F rates, the School of Business and Technology had 11 of the courses. We need to think about what we can do to improve these statistics.

The meeting was adjourned at 12:55 PM.
