- Currently, the BUL prefix is not listed as an acceptable elective in the Computer Science programs, so the wording that this is acceptable for CS students is not accurate.
- The faculty in SOBT would like to discuss this proposal and its broader implications at a department meeting so that all faculty have a chance to discuss this course.





In researching this course at SCNS, because this is a lower level course, it can be used for AA. If it is designated as such, it could also be used in an AS as well. If it is Designated to only AS, it can only be used in that Degree.

The exception for *Spring* 2020:

As you already have the approval of the Provost for an exception, we strongly recommend the courses approval as of <u>Fall 2019</u> even though this may not be offered until Spring. This will ease programming of the degree audit, allow the course to be offered when ready, and will be available for the 2019-2020 catalog rather than the 20-21 edition.
