It was recognized that Level 3 in the ASN curriculum was heavy in course load and overwhelming for students. In the review of the ASN curriculum, faculty felt there was duplication of content in the course NUR 2440 Children and Women's Health and courses in other levels. It was determined that a new 1 credit course (NUR 2424) with obstetrical content would better fit the curriculum. Clinical experiences for obstetrical nursing was incorporated into the level 3 clinical course (NUR 2033L) and NUR 2440L (Children and Women's clinical) will be discontinued. The remaining credit hours were added to courses that would benefit from extra class time (NUR 2033, NUR 2092, NUR 2145, NUR 1020).

A grade of "C" or better must be earned in General Education (16 credits) and Program Specific (14 credits) courses.

The ASN Program uses the following grading system: (90 - 100 = A, 80 - 89.99 = B, 77 - 79.99 = C, 60 - 76.99 = D, Below <math>60 = F)

A grade of "C" or better must be earned in each Nursing/NUR course (42 credits) in order to progress in the program

A grade less than "C" in a Nursing/NUR course will require a reattempt.

A Nursing/NUR course may be repeated or reattempted only once. If a grade of "C" or better is not achieved when the course is repeated or reattempted dismissal from the program will result

Dismissal from the Nursing Program will occur if a student is deemed unsafe or unprofessional in clinical practice/patient care If a grade of "C" or better is not achieved or Withdrawal/W grade occurs in two or more Nursing/NUR courses, dismissal from the program will result

The Academic Review Committee (ARC) will evaluate each student who is unsuccessful in a course or has an interruption in their program sequence. An Alternate program plan will be developed by the committee in collaboration with the student

Attendance and punctuality is mandatory for all classroom, laboratory, and clinical activities. The third and each subsequent classroom absence and/or partial absence will result in a 5-point deduction from the final course grade. Attendance (100%) is required for all simulation and clinical activities.
