Dr. Tropello started the meeting with a few announcements. The staff in Health Professions will work from 9 to 3 on their designated days each week. We will approve the previous meeting minutes at the next meeting.

Pamela Peters provided information about the Trauma Care webinar that will be offered on October 30th via Microsoft Meeting. Attendees who are in the field of social work and nursing can earn 2 CEUs.

Dr. Norman introduced himself and he goes by the name Tom. He is working on a large federal grant totaling \$5 million that are earmarked to support community colleges. He has a great interest in trauma programs. He is also looking into alternate credentialing for our programs and will be in contact with the program directors to work through any issues.

Susan Davis stated that she was a trauma nurse and trauma is the love of her life. She also mentioned that we offer pre-trauma support training through our EMS program.

Dr. Tropello stated that trauma is a good example for this year's QEP on Transdisciplinary Education. She suggested that we get our students involved in undergraduate research on simulation verses the clinical environment.

Dr. Tropello mentioned this year's One Book – Dare to Lead, which covers being courageous as leaders, leading by example, and recognizing the potential in people or ideals. She was intrigued by CS Lewis' quote on page 21 & 22, which includes the points – It is OK to fail and listening is important.

Greg Turchetta thanked everyone for providing valuable information on their program activities this summer. He stated that our programs are full of motivation and every student he spoke with had a story to tell. He stated that he needs pictures for the brochure and requested that we let him know when there are activities and events that can be recorded or photographed. If we need video cameras, they are available to make our own videos of those events.

Cassie Steves stated that they are looking for program highlights for the past year to include in the Foundation donor report to promote funding for the college.

Reports

<u>HIT</u>

- Deborah Howard stated that she is working on a curriculum update to include 2 additional courses required by AHIMA.
- She has a new adjunct that is teaching the Health Data Management course.
- The plan is to market the coding courses on Charlotte campus in the spring and offer them in the fall.

<u>Nursing</u>

- Dr. Voelpel stated that they bought in 100 students, which is more than they have in previous years.
- Angie Vitale completed her Doctorate
- Margaret Kruger is completing her research project.
- They are establishing a chapter of Sigma Theta Tau for the BS in Nursing.
- Dr. Voelpel stated that the Sim hospital positions have not been posted yet.
- Dr. Tropello stated that technical experience, along with scheduling and creating scenarios, should be added to the job description for Hristo's old position.

Dental Hygiene

- Karen Molumby stated that they added a Dental Clinic Manager position, which is needed this semester since we had to add clinical courses from summer to the fall courses.
- They do temperature checks on all students and patients as they enter the clinic.
- They will be 100% computerized this semester to eliminate paper. The majority of the patients are over 65 and it must be done to ensure their safety.

- This semester is their community health semester in which the students work with the community to share their knowledge on oral health. Instead of visiting the various sites, the students are tasked with creating presentations and videos that will be sent to the sites to view.
- The accreditation self-study is postponed 1 year, which will give Karen time to document the changes in their procedures due to Covid.

BS Cardiopulmonary Science & Respiratory Care

- Jean Newberry stated that she is now taking on the role of the Chair for the Cardiopulmonary Program until the position is filled.
- They brought in 30 students for the Respiratory program this year.
- The second year students are unable to go to clinic this semester and have simulation on campus. They hope to send them to clinic in the spring.

Cardiovascular Technology

- Jeff Davis stated that there are 2 new simulators that the students are using in the lab.
- The third simulator Gaumard Hal will be assembled in the next week.
- A letter has been sent to the Sublets, donors of \$500K for CVT, with the invite, but the date has not been established yet.

Radiologic Technology

- Jim Mayhew stated that they are doing well. They have 25 first year students this year.
- They are waiting on PPEs and clinical sites to open.
- All of the graduates have passed the board exam.

AHA- BLS/ACLS/PALS

• Susan Davis stated that 200 students have completed the online version of the BLS and will now be coming to campus to complete the hands-on portion.

Dr. Tropello stated that we need work study presence in the lobby. Karen Molumby stated that they discussed work-study positions in the last reconnect meeting. They agreed that they will not hire work-study since the full time staff is talent sharing and they want to prevent layoffs.

STATE OF FLORIDA OFFICE OF THE GOVERNOR EXECUTIVE ORDER NUMBER 20-213 (Emergency Management -Extension of Executive Order 20-52-COVID-19)

WHEREAS, on March 9, 2020, I issued Executive Order 20-52, declaring a state of emergency for the entire state due to COVID-19; and

WHEREAS, on March 25, 2020, President Donald J. Trump approved my request and declared a Major Disaster due to COVID-19 in Florida; and

WHEREAS, on June 3, 2020, I issued Executive Order 20-139, implementing Phase 2 of my Safe. Smart. Step-by-Step. Plan for Florida's Recovery; and

WHEREAS, I, as Governor of Florida, am committed to providing all available resources and assisting all Floridians and our local communities with their efforts; and

WHEREAS, no state of emergency declared pursuant to the Florida Emergency Management Act may continue for more than 60 days unless renewed by the Governor; and

WHEREAS, the impact of COVID-19 poses a continuing threat to the health, safety and welfare of the State of Florida and its residents.

NOW, THEREFORE, I, RON DESANTIS, as Governor of Florida, by virtue of the authority vested in me by Article IV, Section 1(a) of the Florida Constitution and by the Florida Emergency Management Act, as amended, and all other applicable laws, promulgate the following Executive Order, to take immediate effect:

Section 1. The state of emergency declared in Executive Order 20-52, as extended by Executive Orders 20-114 and 20-166 will be extended for 60 days following the issuance of this order for the entire State of Florida.

Section 2. All actions taken by the Director of the Division of Emergency Management as the State Coordinating Officer with respect to this emergency before the issuance of this Executive Order are ratified, and he is directed to continue to execute the State's Comprehensive Emergency Management Plan and other response, recovery, and mitigation plans necessary to cope with the emergency.

Section 3. Except as amended herein, Executive Order 20-52, extended by Executive Orders 20-114 and 20-166, and as amended by Executive Order 20-192, is ratified and reaffirmed.
