## NUR 3805 PROFESSIONAL ROLES AND DIMENSIONS (3 CREDITS)

This introductory course is designed for the returning RN and focuses on the issues and theories related to current professional nursing practice. The evolution of nursing as a profession and the role of the professional nurse are examined. An overview of selected nursing theorists and professional nursing practice in a dynamic health care delivery system are presented. This course is available to students as an online course and a face-to-face-format that is web-enhanced, requiring students to complete classroom and specific web-based assignments and activities.

#### VIII. GRADING POLICY:

#### 1. Incomplete Grades

The "incomplete" grade ["I"] should be given only when unusual circumstances warrant. An "incomplete" is not a substitute for a "D," "F," or "W." An Incomplete grade must be discussed in advance with the professor.

A student who receives an "I" must make up the deficiency. The responsibility for making the necessary arrangements rests with the student. The professor will determine with the student a schedule that allows for evaluation of assigned work by the professor in order to file a change of grade with the Registrar. A student may not register for a class in which they have an "I" grade. If a grade change is not filed with the Registrar by the date published in the current academic year college calendar, the grade defaults to an "F.

#### 2. Assignment Due Dates

Students are required to complete all course assignments in order to receive a final grade. **All due dates/times are Eastern time regardless of student location. NOTE:** Due dates for assignments, discussion posts, projects, and/or papers are subject to change with notice

#### 3. Late Assignment Submissions

One (1) point will be deducted for each day up until five (5) days past the due date. Course work received over five (5) days past the due date will not be graded and students will receive a zero (0) for the assignment.

Unusual circumstances may allow late submission but the instructor must be notified before the due date and approve the late submission.

#### NOTE:

- Technology is not an excuse for late submission of assignments, discussion posts, projects, or papers.
- Students choosing to go on vacation during the course semester are responsible for submitting all assignments, discussion forum posts, projects and papers by the stated due date. Lack of Internet access is not an excuse for late submissions.

#### 4. APA Format

All papers, assignments, and discussions using citations and references will follow APA format which is included as one component of the grading rubric. Refer to the *Publication Manual of the American Psychological Association* (6<sup>th</sup> ed.) and/ or the **APA Style Blog** 

#### 5. Turnitin

An online plagiarism checker with a permanent storage of all submissions used to ensure academic integrity for written assignments in the RN to BSN Program.

Students are able to access their Turnitin Similarity report in Canvas which will give details of potential plagiarism.

All papers submitted to Turnitin.com must have a Similarity Score of 20% or less. If the Similarity Score is 20% or greater, the student may be given the opportunity to resubmit the assignment.
