Study is not complete yet and he will report final data at next RN to BSN meeting. B. Holbrook will meet with Dr. Voelpel and Dr. Norman to present methods of increasing RN to BSN methods. Currently, Dr. Hays is visiting level 4 classes in ASN and providing information on the RN to BSN and providing student with "what if" report on readiness to start RN to BSN. Currently AS graduates with AA degrees are able to take 3 RN to BSN Program as non-degree seeking students until they pass NCLEX and qualify for admission to the RN to BSN Program.
