The State Course Numbering System determined that the originally submitted course, NUR 2145 Pharmacological Nursing, needed to be changed to NUR 2144, as the X145 number is an upper-level course.

FSW Curricular procedures require a Course Discontinuation proposal for NUR 2145 and a New Course Proposal for NUR 2144 in order to enact this change. We are asking permission to submit both proposals immediately with an effective date retroactive to Fall 2020 (2020-2021 Catalog).

As the new nursing cohort and continuing students need to take this course in Spring 2021, we are requesting an exception to have this new 2144 course created in the Banner Student Information System for the Spring 2021 Semester to comply with the already (state changed) course.

We would appreciate your approval for this exception for the Spring 2021 semester. I apologize for this last-minute request.

Here is the "signed Memo equivalent." This NCP for NUR 2144 includes signatures and an explanation that they are approving the SCNS-mandated change of course number from NUR 2145 to NUR 2144 by allowing creation of NUR 2144 immediately, to be offered in Sp 2021.

The Course Discontinuation proposal for NUR 2145 is a separate action, but I think we can say it's approved by the language in this proposal. Is it ok with you?

In Curriculog, I guess we could just add this NewCP and the CDiscontP for NUR 2145 to p.1 item 7.

Would it be enough to add a note that the New Course Proposal for NUR 2144 contains approval signatures allowing the exception date=12/2020 for both actions to satisfy SCNS requirements? Or do we need a separate Memo specifying both exceptions retroactive to 2020-2021 Catalog?
