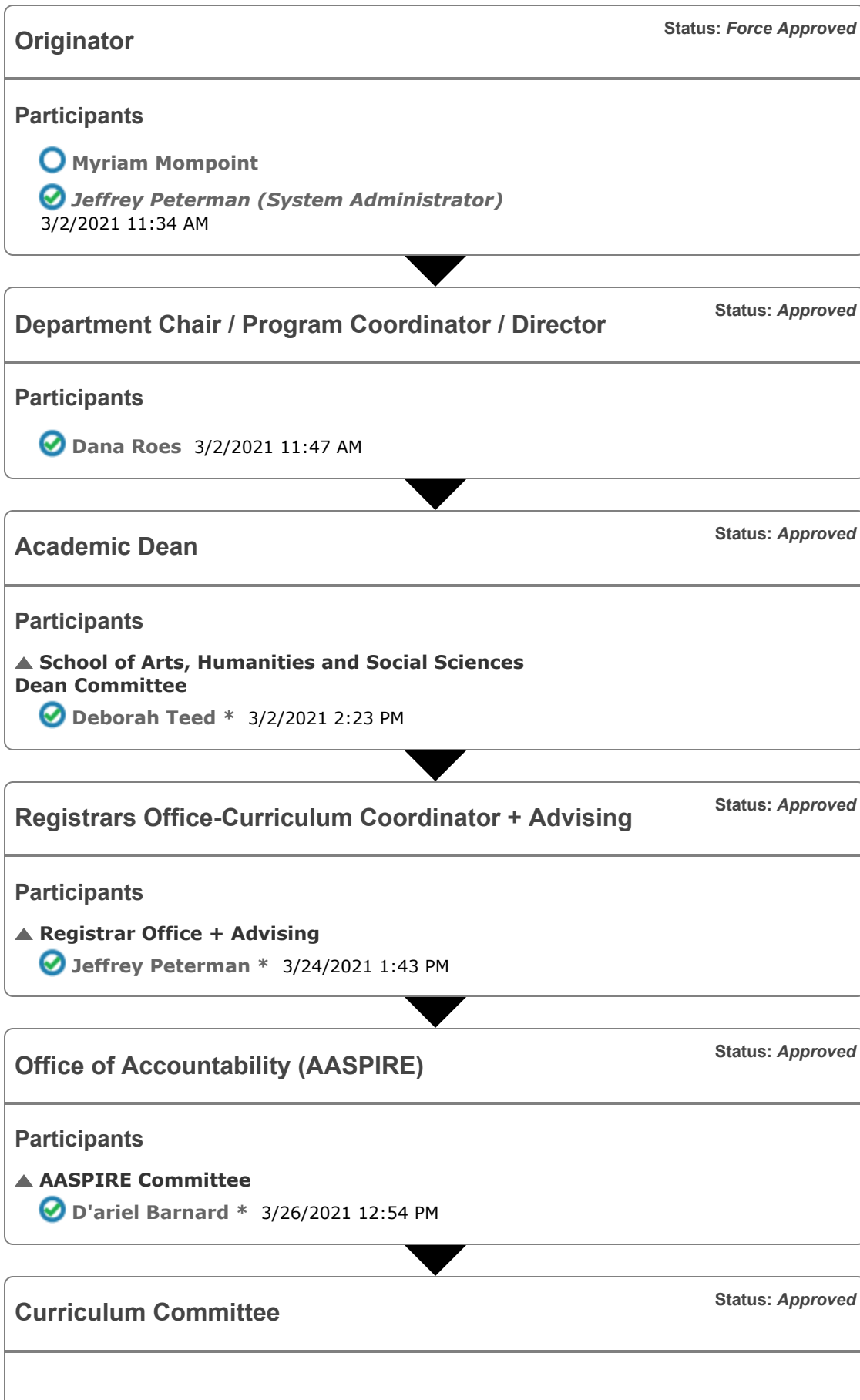

This proposal includes the course syllabus with adjustments: Course description shortened. Writing Intensive language updated to match AHSS-directed changes passed at 2/5/21 Curriculum meeting.

Additional syllabus changes made after 4/2/21 Curriculum meeting, on advice of reviewers: GE Competency Communicate appeared as both Integral and Supplemental; deleted from Integral (Sec IV-A-1); remains as Supplemental (Sec IV-A-2). "International or diversity focus" designation added to course description.
