#### VI. College Credit Certificates

i. Financial Services CCC

Dr. Psihountas presented information on this CCC to the group and discussion ensued about the courses required for the CCC. None of the courses are financial courses. She went through the history of how we started the CCC five years ago for the employees of Suncoast Credit Union.

Dr. Psihountas described a phone meeting with the Vice President of Suncoast Credit Union in October 2020. She also received a report that indicates that only 15 students/employees completed the CCC and 18 are still in process. She indicated that SoBT will be sending letters to both groups of students asking about either going into one of our degrees or will they complete the CCC.

The group discussed making changes to the curriculum of the Financial Services CCC. This CCC may need a complete teach out and restructure to a different Financial CCC with better curriculum. The need for a shorter CCC was discussed. The State of Florida mandates the length of CCCs.

Professor Van Glabek has researched other CCCs online that flow into an AS degree. The degrees were a Banking and Financial Services AS degree with 3 CCCs and an AS in Financial Services with 3 CCCs.

Professor Hoffman asked if Suncoast rewards employees for completing the Financial Services CCC? The answer was unknown.

Dr. Psihountas also gave an update on the AS in Aviation. She said Deelyn Bennett told her that Lorenzo Walker School in Naples has been teaching A/P for years. This could be a feeder into our AS in Aviation.

Dr. Patterson asked for volunteers to working on updating the CCC and Professors Callahan and Van Glabek volunteered to work together on this project.
