## 2. CODA Update

Review documents attached in email- CODA has given DH programs Temporary Flexibility:

Alternative Assessment Methods (for example, patient vs simulation):

- a. Students should have sufficient patient experiences prior to graduation. Programs may use alternative instructional and assessment methods, including distance education, virtual simulations, Objective Structured Clinical Examinations (OSCE), case studies, and other appropriate methods determined by the program to enable the program to continue to provide curricular content and evaluation of student competence. The program is responsible to ensure the competence of its graduates and to document that the assessment methods used provide a sound measure of competence.
- b. Program Directors meeting 4/17/2020 The Florida DH educators will meet on Friday April 14, 2020 to discuss the April 14<sup>th</sup> ruling.
- c. Florida Program Director's Letter- Faculty were provided a copy of the letter sent from the Program Directors to the Governor. ADHA and ADEA have contacted all Governor's throughout the country to request patient simulation examinations be removed for the Class of 2020.
- 3. Budget All budgetary funding has been removed from all programs from supplies and lab fees.

- 16. <u>NBDHE Results for Class of 2020</u>- The NBDHE results were released. The overall Class of 2020 scored 0.56 above the national average for 14-subject areas. The class were slightly under the national average for 8/14 subject areas. The faculty discussed the results and suggested that the program reach out to the A&P department to request a review of material pertaining to Physiology-Chem-Nutrition. This is a category that the program has scored below the national average for the past four years.
