 - Bullet #5, please replace the current sentence with this one:

If a minimum percent score of 77% is not achieved, according to the syllabus grading requirement, in two or more Nursing/NUR courses, dismissal from the program may result.

- add another bullet just below bullet #5:

If a second withdrawal/W occurs within the nursing program, student's case will be reviewed by the Department of Nursing

- 2. Under the section "Standardized ATI Testing" (p. 16)
 - please change note in parenthesis after heading to **(NOTE: Level 1, 2, and 3 excluded)** This change is for the Fall semester.
- 3. Under the section "Criminal Background Checks and Disclosure" (p. 23)
- Second paragraph on p. 23, add the bolded sentence after "...ANNUAL criminal background check and drug test": **Student's criminal background check and drug test must remain current throughout the nursing program.**
