Jenner will work with June in planning RN-to-BSN submission to college-wide curriculum committee. They will meet outside today's meeting to plan. Proposal 1) Create a dual track for AS Nursing students who hold AA or higher degrees, maintain a 3.0 or higher GPA and has finished the first semester of the AS Nursing Program, to change to a new pathway that allows AS Nursing students to take general education courses needed for a BS in Nursing degree and NUR 3000 – 4000 courses while simultaneously continuing AS Nursing Classes. This pathway would qualify for Federal Financial Aid and allow AS students to complete up to 8 out of the 9 BSN level nursing course before the student graduates with an AS degree in Nursing. This should increase the number of FSW AS Nursing students who graduate with a BSN degree to 50% rather

	than the current 28%. The second proposal is change the RN to BSN admission criteria to holding an RN license that allows the nurse to work in Florida. Currently students have to have all general education requirements for a BSN completed for admission. The new proposal will allow Registered Nurses to be admitted to the RN to BSN without having completed all required general education courses. The RN to BSN Student Success Advisor II will create an advising plan that will include required general education courses and NUR 3000 – 4000 level courses. This should increase RN to BSN admissions by 40-50%.		
	B. S. Torres presented overview of NUR 3870 Informatics for Health Professional. Reviewed course description. Will remove statements, "Acceptance into the RN to BSN Program. Current valid, unencumbered, and unrestricted Florida RN license." Also "this course should be taken in the first nine credits in the program." We would add, "acceptance to the RN to BSN program, dual enrollment track or Program Director / Associate Dean permission." Exact language to be determined for Fall 2022 syllabi but something similar to, "acceptance to the RN to BSN program, dual enrollment track or Program Director / Associate Dean.

Holbrook suggested showing S. Torres what is captured in Shadow Health charting; S. Torres agreed to review this in Shadow Health. Grading and activities were reviewed. S. Torres was suggesting there may be too much work in the course for students. Remove statement on page 5 of the syllabus that states, "Successful completion of NUR 3870 is a pre-requisite to enroll in NUR 4165 Nursing Research" due to having a restriction in Banner preventing students for registering for NUR 4165 if the students have not taken NUR 3870 and it is listed on students' advising sheets. Resources for course were reviewed. S. Torres feels we do not need all the assignment listed for week one. M. Jenner suggested taking out the 'student form completion' since it will be included with RN to BSN admission prior for students are able to register for courses. 		
	S. Torres commented that we have a lot of statements in our syllabi. Dr. Weiner suggested that APA manual APA needs to be corrected. S. Torres reviewed weekly assignments. Paused at page 15 in syllabus and will resume on March 12.
