During the 5-Year Course Review process, the following courses had been identified by the faculty and Deans of each School as obsolete, but were inadvertently left off of the list sent to the Board of Trustees. Florida Statute, 1007.24, FAC 6A-10.0331, and FSW College Operating Procedure 03-0605, requires that a review of courses be undertaken and courses removed if the FSW course has not taught during the five years preceding the effective date of the next catalog. However, it is not a requirement that all course deletions are approved by Board action. Therefore, I recommend that in order to ensure accuracy in the Catalog that the following courses, previously identified for deletion by the faculty, be removed from FSW course catalog at the end of this academic year through this memorandum.
