### **Administrative**

### a. **Dental Clinic Renovation**:

- i. Faculty offices and remote laptops The faculty are being temporarily moved to AA-166 during the renovation of the clinic. Faculty requested remote laptops to replace desktops computers. The faculty computers will be moved to the temporary space on June 12, 2023.
  - Faculty will need to take those items needed from their existing work stations since all rooms will be sealed during the renovation project.
- ii. Dental Clinic Chairs will be dismantled and removed on June 12-13, 2023 by Atlanta Dental. The old equipment will be removed by JW Cole and stored outside in the fenced in area by EMS until August.
- iii. Vacation faculty are to complete the new leave request forms. Vacations can be taken at anytime between June 13 and July 31, 2023. Faculty are to be on campus to assist with getting the clinic up and running for the start of the fall semester.
- iv. Fall Clinic Clinic is scheduled to begin August 22,2023 providing the clinic is back in operation due to the renovation project.
  - New Dental Chairs have arrived and are being stored in AA-216 until the renovation project is complete. These new chairs are expected to be installed by August 21, 2023.
  - IT will need to set up all equipment in every operatory as well as in the radiology area.
- v. Ordering of Clinic Supplies All supplies for the clinic will be ordered between August 1-15, 2023. The exact date will be determined based on the date the clinic permits faculty to be in the clinic.
- b. <u>Enrollment Increase and H22</u>- Due to Hurricane Ian, the program will accept 18 students plus add the two students who have the H22 option. One H22 declined seat.
- c. <u>Simple Syllabi</u> The College will be using the Simple Syllabus Program to house all syllabi's. This program permits many options to make categories public and private. The State of Florida requires certain categories to be available to the public. The goal is to incorporate Simple Syllabus in the fall semester.
  - i. A demonstration PP was shown for faculty. Faculty will be required to input their data for approval and then the Deans followed by VPAA final approval. Clinic courses will be completed by the program director. All didactic courses will have information imported that are standardized by the college, imported by the program director and then information added by the faculty.

# d. Interview Committee Faculty

i. Dental Hygiene Clinical Instructors served on the interview committee for the Clinical Coordinator, Dental Hygiene position. The goal is to have this person in place by July15, 2023.

# e. Front Office

- i. Fall Schedule- the fall schedule will have the patient(s) who will be screened to fill cancellations for students that are scheduled to treat patients.
- ii. The recall system and inactivation of patients is the goal over the summer to revise and ensure to patients that need to be active are listed on recall lists.
- iii. Dental Clinic Website Jaslyn will work with IT to help establish a website for the dental clinic. The goal of the website is to permit access to new patient forms, clinic information and to include other upgrades such as:
  - Establish a second separate email to receive completed new patient forms.
  - Establish the ability to send electronic confirmation of appointments.
  - Other systems to improve communication with the public.
- iv. Patient Survey week Will occur for two weeks in September/October.

# f. Accreditation updated documents-

1. Verification of Textbooks, instruments, small and large equipment documents will be updated as received from the vendors. One of the Clinical Coordinator will assume the responsibility of updating the faculty course textbooks and the instruments and equipment.

# d. Clinical Issues

- i. Tal eval
  - Tal eval will only be completed for new patients for the rest of the program for the class of 2024.
    - a. No summer chart reviews and/or clinical advising was implemented due to the number of days on the clinic floor to ensure clinical dates could be completed.

# ii. <u>PPE protocol</u> -

- The PPE for the students will include a face shield, hair net, two masks, and safety glasses.
- Faculty will continue to wear disposable gowns and use mobile carts.
- **Defogging** The defogger will be used provided as an option task in clinic.

# g. Summer Course Syllabus and office hours:

- i. DEH 2804, Dental Hygiene III were posted by the first day of summer classes in April 2023.
- ii. Faculty office calendars are to reflect when they are in the office.

# e. Faculty Clinical Evaluations (Spring 2023)

Faculty evaluation results were provided in April and their Clinical improvement plans completed by May 5, 2023.

# f. Program Examination and Licensure Examination Statistics

- a. <u>NBDHE</u> The Program pass rate was 100%. For 28-years the overall pass rate is 99.8%. National Board scores were shown.
- b.  $\underline{\text{CSCE}} 100\%$  pass rate for 13-consecutive years
- c. <u>MTCE-</u> The result of the MTCE exam for the Cohort Class of 2023 94% on the first attempt.
- d. <u>Florida Law Exam</u> –A 100% pass rate on the first attempt was achieved by the Cohort Class of 2023.

# g. Program Statistics

- a. Class of 2023 The Program Exit Survey which is designed for students to evaluate their progress throughout the entire program was distributed. The response rate was approximately 56%. Three reminder emails were sent to the Cohort to obtain as many responses as possible. The survey was distributed for faculty review.
- **b.** 6-month graduate Survey: Class of 2022: The graduates support the engage of 5-8 patients/day to assist with the transition from school to private practice.

### h. Program Award Letter -

- a. The 2023 program award letter notifications were presented to the recipients after their last clinic day.
- i. <u>St. Petersburg College BASDH Application</u>: Class of 2024 No applicants expressed an interest in obtaining their BS degree during the program.

# j. Program Selection:

a. Class of 2025 – 30 Candidates were asked to complete the CBC/drug screen. Only 29 completed this requirement. 18 applicants were sent acceptance letters and 11 received alternate letters.

- m. <u>Perkins Funding</u>: Faculty will need to make requests for small and large equipment for the classroom and/or clinic.
  - a. Two human radiology skulls have been recommended for 2024. The cost is 17,000/manikin and 140000/ case.

# n. Program Goals and Mission Statement:

The Program goals will remain the same. These goals are listed in each course syllabus. How the goals are met is documented in a program report and transferred to the Compliance Assist report at the end-of-the semester. The final report is completed by the end of June. The use of results is the information transferred to the next academic year.

- o. Instructor Key Concepts for ALL Professors Topics discussed were:
  - a. FERPA
  - b. Course Syllabus will be Simple Syllabi.
  - c. Remediation clinical and didactic remediation was explained and protocol reviewed. Faculty were provided a copy of the remediation form as a reference.
  - d. Examinations and Quiz Policy on Campus faculty who use A-142 computers to administer quizzes and test in the classroom must have a password to be given the day of the exam. The purpose is to minimize cheating on examinations.
  - e. Proctorio Examinations require students to have the appropriate computer requirements and a webcam.
  - f. Release of Semester Examinations Exams are not released until the last exam has been taken. These examinations are not reviewable by students.
  - g. Learning Activities Time allotment Assignments Textbook Chapters are required for all course Extra credit can be given but no food and/or gifts are permitted.
  - h. Study guides with test topics should not be provided to students. Reviewing material is an option.
  - i. Instructional objectives are used to formulate quiz/exam questions. These questions are used to evaluate the success of the material covered in the course.
  - j. Classroom down number 11203 was explained to all faculty. Password is changed on a monthly basis. Whoever changes the password must send a text to all faculty to inform them of the password change.

# p. Institutional Effectiveness (IE)Report - June 2023: Compliance Assist Reports

# 1. <u>NBDDHE</u> –

**Results**: The DH program has a 99.8% pass rate on the NBDHE. The class of 2023 scored a SD of 1.86 and tested above the national average in 14/14 subject areas.

**Use of Results**: The dental hygiene course final examinations will continue to focus on the inclusion of a case-study question format to maintain an overall standard deviation score above the national average.

2. <u>CSCE</u>-

**Results**: 100% of the Cohort Class of 2023 passed the CSCE examination on their first attempt for the 12<sup>th</sup> consecutive year.

**Use of Results**: The program will update the mock didactic exams. The results from this examination will assist the program in improving SLO in dental core courses and to ensure students pass the CSCE for the 13th consecutive year for the Cohort Class of 2024.

3. MTCE - Clinical Board –

**Results**: 94% of the Cohort Class of 2023 passed the MTCE examination on their first attempt. Use of Results: The dental hygiene will continue to do a mock board MTCE examination using models that will mimic the MTCE examination sponsored by ADEX.

4. Florida Law Examination -

Results: 100% of the Cohort Class of 2023 passed the Florida Law Examination.

**Use of Results**: the mock Florida law exam in the DEH 2930, Seminar course will maintain an "open-book" and computerized format to maintain the programs' 100% pass rate on the Florida Law exam for the Cohort Class of 2024.

- 5. Patient Surveys 2022-2023 Annual Patient Survey
  - a. Patient Care Services Response Results:

**Results:** The program captured 103 annual patient survey responses as well as a 96.8% of the respondents were satisfied with the student's delivery of patient care services as measured by the patient surveys collected for the AY 2021-2022.

**Use of Results**: T At the June 12, 2023 faculty meeting, the faculty reviewed the survey feedback and will continue to distribute the patient surveys 1-2x/semester to increase the patient ranking of very good to excellent satisfaction to >90% in the delivery of patient care services for the AY 2022-2024.

b. Operational Outcomes Response

**Results**: 91.3% of the respondents stated that their experience was very good to excellent. **Use of Results**: The clinic was closed for three months due to Hurricane Ian. The respondents that were treated between January -April 2023 were very appreciative of the service, the response time in returning phone calls, dental clinic hours of operation and cost. At the June 12, 2023 faculty meeting, the faculty reviewed the survey feedback and will continue to distribute the patient surveys 1-2x/semester to increase the patient ranking of very good to excellent satisfaction to >90% in the delivery of patient care services for the AY 2022-2024.

# 6. Class of 2023 – Program Exit Survey

**Results**: The AS Dental Hygiene Class of 2023 respondents were satisfied with their ranking of agreeto-strongly agree for the 59/59 survey questions. The areas of concern were related to dental materials, expanded functions, indices, provide services for 5-8 patients/day and provide life support measures for medical emergencies.

**Use of Results**: The faculty discussed at the June 12, 2023, the nine responses from the Cohort Class of 2023. The areas of concern were related to dental materials, expanded functions, indices, provide services for 5-8 patients/day and provide life support measures for medical emergencies. Hurricane Ian affected the programs ability to participate with the EMS students due to the college being closed to classes on campus from October 1- November 4, 2022. The program will be able to resume the EMS/DH simulation activity on November 9, 2023 and be able to incorporate the 6-8 patients' protocol in February and continue through April for the AY 2023-2024.

7. Quality Assurance (DHCP and Patient Chart Review): - Analysis:

**Results**: The 2022-2023 results reveal the students scored an overall program average of 85.5% for the patient and DHCP chart review.

**Use of Results**: he Cohort group was impacted with Hurricane Ian and inoperable IPAD computers that limited the program in the collection of quality assurance data. During the June 12, 2023 faculty meeting, the faculty determined that the goal for the Cohort Class of 2024 would be to resume quality assurance data collection using the surface pros to maintain a program average of >90% to address all the components of the ADPIED, Dental Hygiene Process of Care model to prevent medical errors in AY 2023-2024.

### 8. <u>Clinical Advising Class of 2023</u> –

**Results:** The Cohort Class of 2023 scored an overall class average of a 90.8% for the clinical and capstone performance skill evaluations required to progress through the program as measured by the programmatic analysis of the ADPIED, Dental Hygiene Process of Care for the AY 2022-2023. **Use of Results:** Errors in documentation was a common theme for this group. The goal of the faculty is to require students to complete the documentation at each instructor procedural check verification to eliminate and/or reduce medical errors. The goal for the Cohort Class of 2024 will be to maintain an overall programmatic class average of >90% for the clinical and capstone performance skill evaluations for the AY 2023-2024.

9. Faculty Clinical Instruction Analysis – DEH 1802L and DEH 2808L Faculty Evaluations.

**Results:** The Class of 2023 and 2024 scored the faculty most common in the "Most-of-the Time to Always" in all categories as measured by the Dental Clinical Faculty survey. This year five new faculty taught their very first didactic course due to the retirement faculty. Their courses directly transfer the theoretical concepts to the clinical environment.

**Use of Results**: The goal for the faculty is to improve the overall programmatic instructional ranking of >90% for all clinic survey categories for the AY 2023-2024.

10. <u>Program Analysis Results for the Class of 2023</u> - The faculty reviewed the program outcomes obtained by the Class of 2022. This information is collected for every clinical course. The information is used to identify areas to either maintain or improve upon within the program.

# a. ADPIED, DH Process of Care:

**Results:** The Program implements clinical competencies and capstone evaluations to identify whether students are competent in the application of theoretical concepts in the delivery of patient care services in a clinical setting with diverse populations. The Cohort Class of 2023 scored an overall class average of 97% for their performance on clinical and capstone skill evaluations required to progress to graduation.

**Use of Results:** During the June 12, 2023 faculty meeting, the goal for the Cohort Class of 2024 is to maintain an overall programmatic class average of >95% for the clinical and capstone performance skill evaluations for the AY 2023-2024.

### b. <u>Program Analysis of Patient Types</u>:

**Results:** 100% of the AS Dental Hygiene Cohort Class of 2023 provide dental hygiene patientcare services to **119** patients/student to include 17% diverse populations that are classified as specific periodontal case types for the child, adolescent, adult, geriatric and special-needs designations.

**Use of Results:** The goal for the Cohort Class of 2024 is to maintain a programmatic average of >125 patients/student of which more than 17% will be special needs.

### c. <u>Program Clinical Radiographic Patient Exposure Progression:</u>

**Results:** 100% of the AS Dental Hygiene Class of 2023 scored an overall program average of 93% to effectively expose, process and evaluate radiographs as measured by the radiographic competencies.

**Use of Results:** During the June 12, 2023 faculty meeting, the faculty will continue to reinforce equal distribution of radiographic exposures. By the end of the spring 2024 semester, the Cohort Class of 2024 will maintain an overall program average of >90% to effectively expose, process and evaluate radiographs for the AY 2023-2024.

# **<u>IE – CODA</u>** - STUDENT LEARNING OUTCOMES/CURRICULUM REVISION

11. <u>Curriculum Revision for spring 2023 Course</u> -The faculty review the curriculum each semester by having each individual course instructor discuss their Student Learning Outcome results and how they plan to improve their course(s). The courses reviewed in spring were: Expanded Functions, Pharmacology, Periodontics, Dental Hygiene II & V, Seminar, Radiology and Dental Hygiene II & V Clinic.

### 1. DEH 1802 Dental Hygiene II Comprehensive Final Examination-

**Results**: 95% of the Cohort Class of 2023 scored a three or higher on the final exam. **Use of Results**: The topic of fluoride needs to be addressed/improved. The question missed the most was on the Dean Fluorosis Index. For next year, I will incorporate learning activities after reviewing Fluoride PowerPoint.

### DEH 1802 Dental Hygiene II Written-Oral Assignments:

a. Smoking-Cessation

**Results**: Class of 2024 scored an average of 97% on this assignment. Use of Results: Deficiencies were noted for presentation topic and time frame

 b. <u>Nutritional Counseling</u> Results: The Cohort Class of 2023 scored an overall class average of 96%. Use of Results: Deficiencies were noted for grammar, spelling and format issues.

# 2. <u>DEH 1802L-: Dental Hygiene II Clinic</u>

**Results**:100% of the Cohort Class of 2024 scored a class average of 96.2% on all DEH II patient care competencies

**Use of Results**: The students had the benefit of taking multiple FMX and Panoramic radiographs this semester in clinic and GKAS day. These exposures are a result of incorporating a family day and

moving GKAS day back to March to take advantage of panoramic exposures earlier in the program. The program will continue to be in place for the Cohort Class of 2024 to enhance theoretical concepts.

### 3. <u>DEH 1602 Periodontics Comprehensive Final Examination -:</u>

**Results**: 92% of the Cohort Class of 2024 scored a 3 or higher on the final examination Use of Results: Use additional power points in the discussion of nonsurgical vs surgical periodontal therapy and include videos of the procedure. Also make sure that the concepts for non-surgical therapy and maintenance are reinforced in regards to host modulation and systemic diseases.

### 4. DES 1200C Dental Radiology Comprehensive Final Examination:

**Results**: 75% of the Cohort Class of 2024 scored a three or higher on the final examination. **Use of Results**: Goals to improve in teaching legal/ethical considerations for radiograph, basic principles of dental radiography and ionizing radiography. This is an area that they review themselves at home. Will try to incorporate Pear Deck to be able to ask them polling questions on the subjects they were supposed to review themselves or possibility incorporate pre/post quizzes. To see how well they are understanding the subject. Was a little surprised by the technique/landmark interpretation errors as evident by the lab competency results. I think students are answering the questions to quickly. They are not taking the time to reading the entire question. When key words are overlooked in the landmark description, they choose the incorrect answer. I do feel like students do not utilized their full time allotted for the exam because so many of them finish early.

### Radiographic Interpretation - Lab section

**Results**: 100% of the Cohort Class of 2024 scored a three or higher on the final examination. **Use of Results**: Goal is to improve scores overall by continuing to work on different learning activities in the classroom to continue to help students with interpretation and technique evaluations. Example might be to incorporate Pear Deck into my learning activities in the classroom so all students have a fair chance at answering the questions.

#### **Radiology Research Paper**

**Results**: 99% of the Cohort Class of 2024 scored a 2 or higher on the research project. **Use of Results**: Overall, very pleased with the scores related to the research paper. Still seeing that points are taken off in grammar and APA categories. Goal for next year will be to continue improvement in grammar and APA by utilizing the Purdue Owl Website and making sure students are aware of the FSW writing center.

### 5. <u>DES 2832C Expanded Functions Comprehensive Final Examination:</u>

**Results:** 97% of the Cohort Class of 2022 scored a three or higher on the laboratory competencies. **Use of Results**: Use of Results: This class performed satisfactorily on this exam with scores ranging from 48% to 92% with a class average of 78%. There are questions that involved critical thinking in relating these topics of clinical dentistry to actual clinical practice. Additionally, there is an emphasis on how the Florida Statutes relate specifically to the topics being presented. This class was very engaged in the lectures which were all voice overs and discussions throughout the semester and at the end through Zoom, which enhanced the learning environment and there was significant interest in the topics as they relate to clinical practice which culminated in the final exam results. The treatment planning sessions were an integral part of the course with the goal of having the students apply the knowledge they have learned through a "back and forth" dialogue with each individual student about their specific case through Canvas. This encouraged critical thinking regarding current concepts, as well as the actual



treatment presentation itself. My goal was to have them view oral health and oral health care on a comprehensive basis. This discussion progressed and culminated with the actual presentations. But due to the onset of pandemic, I changed this presentation as voiceovers and peer review. The student's presentations ranged from excellent to mediocre. The students level of understanding on various aspects of clinical dentistry, that will be presented in every day practice was outstanding and I feel it was a success.

### DEH 2832C Laboratory

**Results:** 74.9% of the Cohort Class of 2023 scored a three or higher on the laboratory competencies. **Use of Results**: There are questions that involved critical thinking in relating these topics of clinical dentistry to actual clinical practice. Additionally, there is an emphasis on how the Florida Statutes relate specifically to the topics being presented. This class was engaged in the lectures which were all voice overs and discussions throughout the semester and at the end through Zoom, which enhanced the learning environment. The treatment planning sessions were an integral part of the course with the goal of having the students apply the knowledge they have learned throughout their education into an actual clinical situation. I initiated preparation well in advance through a "back and forth" dialogue with each individual student about their specific case through Canvas. This encouraged critical thinking regarding current concepts, as well as the actual treatment presentation itself. My goal was to have them view oral health and oral health care on a comprehensive basis. This discussion progressed and culminated with the actual presentations which were voice overs and peer review. The student's presentations were good, some excellent some below standard. I felt the students lost their enthusiasm at the END. and there was NO significant interest in the topics relating to clinical practice, and felt as a negative from this class. I am hoping a different outlook from the future class which will help with a better performance

# 6. DEH 2300 Research Report

# **Pharmacology Research Paper**

**Results**: 100% of the Cohort Class of 2024 scored a three or higher. Use of **Results**: The goal of this assignment is for the student to research various drugs commonly used in the local patient demographics and apply the didactic knowledge of the pharmacology of these drugs to a practical clinical example. The papers were fairly well written with an acceptable level of effort put into the assignment by the great majority of the students. This assignment will be continued for the next year.

# **Pharmacology Comprehensive Final Examination**

**Results**: 92% of the Cohort Class of 2024 answered 6 out of 10 questions on the final exam/outcome correctly. The final Cohort Course final exam average was 75%. **Use of Results**: The professor's background teaching in the clinic will help the students to understand the relationship of the medical condition with the interaction of several drugs and its effect on oral health. The relevant and necessary information was explained to the students. Following the results above I would recommend adding polls and other learning activities during the course to allow for more engagement and better understanding of the material to make it easier to apply in practice.

### DEH 2808L Dental Hygiene V Clinical Competencies -

**Results**: The Cohort Class of 2023 overall course average for patient care and radiographic competencies was 96.7%. **Use of Results**: The program will maintain the current competencies.

### 7. DEH 2808 Dental Hygiene V Resume

**Results:** The Cohort Class of 2023 scored a class average of **94%** on the Resume Assignment. **Use of Results:** The overall appearance of the resume was fantastic. The errors that the Cohort had was reversing the of the education and work experience section and omitted the community service on their resume. The PP will need to emphasize that a new graduate will need to have their degree listed first and then their work experience since the job they are seeking as a dental hygienist will be a first-time employment situation.

### 8. DEH 2930 Seminar

#### **Portfolio:**

**Results:** 95% of the Cohort Class of 2023 scored a three or higher on the portfolio assignment. **Use of Results:** Students added an image to each page which made the presentation more appealing. The students did an excellent job portraying who they are and goals for their careers.

#### **DEH 2930 Case Presentation:**

**Results**: 100% of the Cohort Class of 2023 scored a two or higher on the case study assignment. **Use of Results**: The students presented excellent case study presentations. The quality of radiographs and IOC photographs enhanced their presentation. The voice-over presentations were outstanding.
