Job Purpose

The purpose of the Program Director, Associate of Science Cardiovascular Technology (AS CVT) is to serve as the program administrator of the Invasive Cardiovascular Technology program within the School of Health Professions. Work includes planning, implementing, directing, and evaluation of effective and efficient instructional systems within available resources, consistent with regional and program accreditation standards, federal and state statutes, and the College mission.

General Responsibilities

Essential Functions

Provides instructional support, as assigned, in the delivery of didactic, clinical, laboratory, simulation, and online/remote education within the AS CVT program and possibly the Bachelors of Science Cardiopulmonary Sciences (BS CPS) program.

Teaches one (1) course per semester (Fall and Spring) in area of expertise/credentialing, up to three (3) semester hours per course, as assigned by the supervisor. Establishes and interprets AS CVT program policies and procedures consistent with College instructional policies.

Establishes AS CVT program goals and objectives in cooperation with the Dean of the School of Health Professions, Associate Dean of Health Professions, CVT program advisory committees, if applicable, and/or CVT and other program faculty/administrators.

Provides an effective organization through the hiring, training, evaluation, and motivation of AS CVT program instructional and support employees. Develops and maintains an organizational structure that ensures effective and efficient CVT program operations and student learning outcomes.

Provides an effective and efficient system for assessment, delivery, and evaluation of CVT program courses; monitors the instructional delivery system and provides guidance for the improvement of instructional quality on a regular scheduled basis to ensure uniform and consistent practice within the AS CVT program guidelines.

PROGRAM DIRECTOR, ASSOCIATE OF SCIENCE CARDIOVASCULAR TECHNOLOGY

Provides an effective communication system within the CVT program and with associated external agencies, community groups or other related organizations to foster the exchange of ideas, while providing opportunities for faculty and staff to participate in developing recommendations to enhance the CVT program. Prepares and recommends the CVT program budget; monitors expenditures to maximize the utilization of available resources.

Recruits and advises students who demonstrate an interest in the CVT program; creates and manages recruitment events as appropriate for the CVT program.

Coordinates student learning experiences and provides guidance to students to ensure retention and student success.

Secures and maintains facilities and equipment assigned to the CVT program.

Provides accurate and timely information for the printing and publication of class schedules, CVT program recruitment brochures, information/application packets, the CVT program webpage, and the College catalog.

Maintains continued invasive CVT program accreditation status with SACS and the appropriate program accrediting agencies (CAAHEP and the JRC-CVT); manages and accepts responsibility for the outcome of future accreditation/reaccreditation processes.

Compiles measurable outcomes of CVT program effectiveness and student success.

Coordinates and participates in the CVT advisory committees, department meetings, and other ad hoc committee work, as assigned.

Performs other duties, as assigned.

These essential job functions are not to be construed as a complete statement of all duties performed; employees will be required to perform other job-related duties as required. Knowledge, Skills and Abilities

Minimum Qualifications

Master's degree from a regionally accredited institution of higher education in a discipline appropriate to the CVT program.

OR

A Bachelor's degree from a regionally accredited institution of higher education in a discipline appropriate to the CVT program may be considered in combination with other appropriate and alternative qualifications as outlined by the Southern Association of Colleges and Schools (SACS) and CAAHEP/JRC-CVT faculty credentialing guidelines.

Five (5) years of combined clinical professional work and invasive CVT teaching experience in the invasive cardiovascular technology (cardiovascular catheterization laboratory) program area. Credentialed and in good standing as a Registered Cardiovascular Invasive Specialist (RCIS).

Personal and educational philosophy compatible with the mission, goals, and objectives of Florida SouthWestern State College.

Demonstrated competency in computer applications.

Demonstrated experience using a personal computer, office software such as MS Office and electronic mail.

Demonstrated ability to:

- Work effectively with all constituencies of the College.
- Collect, organize, analyze and present information in a meaningful manner.
- Collaborate and be effective working with diverse populations.

Critical Skills/Expertise
