
Enrollment is currently similar to last spring – dual enrollment numbers are lower, but new students numbers are higher. Returning student numbers are very strong!!







SPAS Updates – Summer & Fall



- Planning will begin next week for Summer and Fall Classes
- Pre-assigning/changing classrooms policies (labs/accommodations/group)
- Summer Schedule
 - Will make initial classes section based on last summer, goal is to spread the opportunities evenly
 - Gus has the Qualtrics Survey ready please fill that out as the first way to submit your requests!
 - Advisors are recommending "harder" topics and 4 credit hour classes be taken full term, dual enrollments students only allowed one class each mini-session

SPAS Updates – Bookstore Update!



We will be getting a new bookstore vendor for Fall of 2024!!

- We are currently in contract negotiations with BibliU who will replace Follett
- Textbook adoptions
 - Summer adoptions should be done through Follett
 - Fall adoptions will be done through our new vendor and an entirely new system (good for Andy!)
 - BibliU is set up to support both OER and Inclusive/First day access

What does this mean for us? (as far as I know now!) (Much more to come)


I will asking all courses have their Fall textbook adoptions be delivered as an integrated Canvas BibliU link either through **OER or through Inclusive/First Day Access**

Exceptions to this need to be coordinated through the Dean (me!)

I am not asking you to change the adoptions – just the way they are delivered (and priced) to the students



SPAS Updates – Student Inquires



Summary of student inquiries

- Grade disputes
- Not responding to communications in a timely manner
- Confusion over course policies (late work, proctoring standards, gradebook updates)
- Proctoring Inquiries have lowered

How to help avoid these

- Clear late grading policy (syllabus)
- Let your students know how to communicate with you (syllabus)
- Answering emails (generally with in two working days), even if the answer is "No" (answer timeframe and method in syllabus)
- Keep your course scheduled and grade book up to date (in canvas)
- Flexible policies for emergencies (drop lowest grade, makeups with documentation, replace missed exams with final, etc.)

How we respond:

Andy starts by asking for more information (proof the student has tried to resolve the issue with their instructor, and checking the syllabus for stated policies). If that does not resolve the issue, he forwards to me (or Gus as needed), and I reach out to you!

- Faculty need to confirm which ceremony they will be attending (details from VPAAS Office) or submit leave form in March






