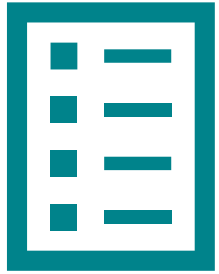

- **Due to Andy Sept 18th**
- Spring will most likely roll from fall – but now is the time to form textbook committees if there will be a change for Fall 2025 – due in March.

- *I am asking you to think through implications for fellow instructors and for your students when choosing both textbook AND **format!***

For example, Section 101 is a traditional class meeting on Lee Campus, Section 901 is a Live Online Class meeting in Zoom, Section 30B is a Blended class with a ground component meeting on Charlotte campus, Section 90B is a Blended course meeting online, and Section 70F is a Flex course with the instructor at Hendry Glades, but a class that students can attend in person or via Zoom.

| Instructional Method | Description | Location |
|---|--|----------------|
| FSW Online  | In an FSW Online course all of your instruction and coursework occurs through Canvas, and you are not required to attend any scheduled class meetings. Instructors may offer optional synchronous meetings, but not require them. ProctorU or Proctorio or “Alternate Testing Location” | Online Only |
| FSW Live Online  | FSW Live Online courses are a special version of an online course where instruction occurs via Zoom during a regularly scheduled time. ProctorU or Proctorio or “Alternate Testing Location” | Online Only |
| FSW Blended Online  | In an FSW Blended Online course you will meet in a virtual Zoom classroom for some class meetings and also be required to complete coursework delivered online through Canvas. You do not have to come to campus. ProctorU or Proctorio or “Alternate Testing Location” | Online Only |
| FSW Blended On Campus  | In an FSW Blended On Campus course your professor will mix required on campus class meetings with online coursework. The online portion of the course may be live in a virtual Zoom classroom or all asynchronous in Canvas. Testing Center for Make-up Exams and Adaptive Services - ProctorU or Proctorio | A mix of both |
| FSW Traditional  | In an FSW Traditional course you will be expected to meet on an FSW campus on a regular weekly schedule. Testing Center for Make-up Exams and Adaptive Services | On Campus Only |
| FSW Live Flex  | In an FSW Live Flex course, you choose how you attend each class. You can opt to come to campus for every class, join virtually by Zoom every class, or a mix that fits your needs. The class will always meet together at regularly scheduled times, but some classmates will be attending virtually. SPAS Updates – BibliU!



- Inclusive Access vs Print
 - All SPAS courses that require material are now in inclusive access except Labster
 - OER course all excluded – continue to provide through Canvas
 - MCB – textbook inclusive access, lab manual (print or Labster) through bookstore
- Three types of Inclusive Access
 - ebook: Retrieved in BibliU library - material will be accessed through BibliU/course materials link in Canvas
 - Courseware with Access Codes: Retrieved in BibliU library, redeemed on publisher site - Codes will be accessed through BibliU/course materials link in Canvas
 - Courseware with LTI/Deep integrated Courseware: Material will be accessed via a direct link to the publisher in the Canvas Course

SPAS Updates – BibliU!



- OER: Course Level Adoptions
 - CHM 2025, CHM 2045, CHM 2046, CHM 2210, CHM 2211, CHM 1020C
- OER exceptions can be done at a section level.
- Simple Syllabus / Master Shells
 - Inclusive Access info in the SPAS Simple Syllabus Template – needs updating??
 - I turned off the block in all Course Level OER adoption in the master template so it should not be in OER courses – if it did get pushed, please let us know
 - For section level OER adoptions, please make that block not visible as you update your course materials to be different from the adopted course level materials



SPAS Updates – Quick Assessment Overview

SPAS Course Refresh

- **For Course Maintenance!**
- To help simplify routine course maintenance needs – too many courses to do all of these items every year
 - Master Syllabus
 - Textbooks
 - Master Shells
 - Assessments Requests
 - Concurrent course requirements
- Review courses on a rotating 5-year cycle – so 20% of a department's courses annually

Course and Program Assessment

- **For Accreditation!**
- Programs, not schools or departments, are generally accredited
- We do complaint assist reports for three programs:
 - AA in General Studies
 - AS in Science and Engineering Technology
 - Certificate in Scientific Workplace Preparation
- Through Team AASPIRE
- Course assessments feed program assessment – 3 math/3 science per year minimum from these programs

Healthcare Benefits

- FSW is transitioning to the State Benefits Program to provide our employees with a more cost-effective and comprehensive benefits package.
- It looks like the state changes to our healthcare options, to include new pricing models, will be effective starting January of 2025.
- **This will mean that we will all need to pay particular attention to benefits open season starting this October 14.**

After you obtain your LDA from your professor, save the entire email communication as a PDF. You must attach the email communication as a PDF in a later section of this form.

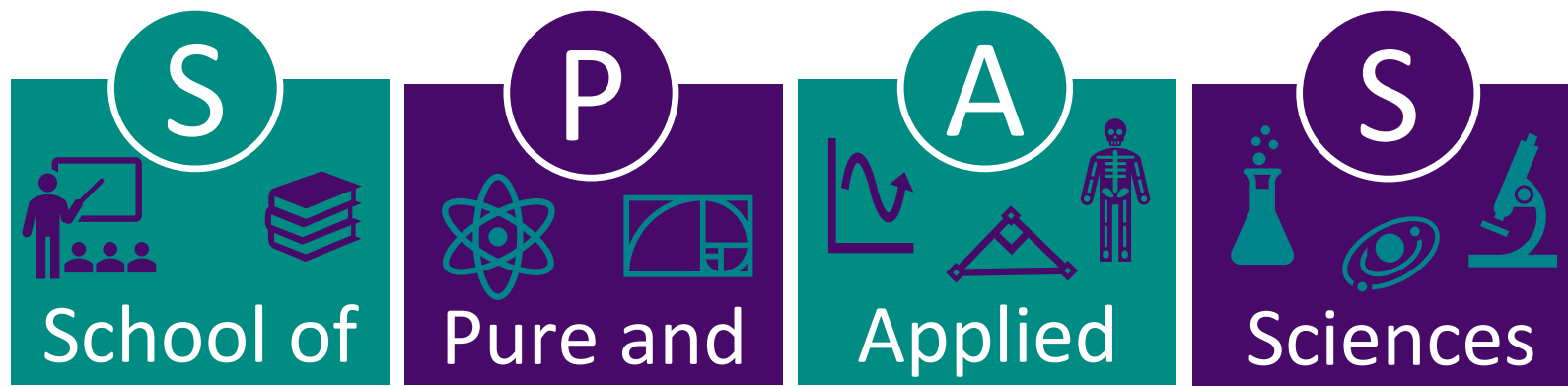
