



What does this mean for you?

- That there is a new way to "sign" late drop/withdrawal form

Your last date of attendance (LDA) in the course being petitioned.

To obtain this date, you must email your professor and request that they provide you with your LDA. <u>Click here for a sample email template</u>. After you obtain your LDA from your professor, save the entire email communication as a PDF. You must attach the email communication as a PDF in a later section of this form.

I am petitioning for a Late Drop or Late Withdraw of your course, *ENC 1101, English Composition I*. In line with this, could you please reply with my Last Date of Attendance (LDA)?
