A. Discussion:

We discussed the leadership changes at the School of Health Professions. Dr. Elizabeth Schott is our acting Dean. Decision for a search committee will be Spring 2025.

B. <u>Discussion:</u>

We discussed the fall courses. Everyone was asked to check their assignment due dates. Also, reminder to review Simple Syllabus in their courses and a reminder to keep the Canvas Schedule (private – for students only). We no longer use paper syllabi. The Syllabus & Textbook Information page in the course refer students to use the Simple Syllabus. HIM 2210 and HIM 1430 have been completed by the instructional designers and the new courses are being used this Fall. Communication and Feedback is a new page that is added to courses to meet QM rubric. We have several courses that have low enrollment due to the "teach out" and change of sequence of courses.

Action:

1. Dr. Foster will continue to report on any updates to courses.

C. Discussion:

We are in the process of mapping of assignments that assess the FEM Competencies. We are developing a Heat Map (all competencies and PIs). Our curriculum synopsis is due 9/30/2024 and our CAHIIM Standards are to be resubmitted by 9/30/2024.

Action:

1. Dr. Foster asked that all faculty review their courses and provide feedback on assignments that map to the FEM Competencies. This is part of our process for updating to the new CAHIIM standards and competencies.

D. Discussion:

Our CAHIIM Self-Assessment requires updated Professional Development Tracking for Faculty forms. We are required to track training and professional development for FEM, curriculum, competency-based education training as well as areas/domains of HIM.

Action:

1. Dr. Foster requested that everyone submit an updated Professional Development Tracking sheet for AY 2023-24 in the HIT Faculty Colloquium Canvas Course by 9/20/2024.

E. Discussion:

We will be hosting a SWFHIMA meeting on September 21. Recommended to invite students to be used for experiential learning credit.

Action:

1. Students in HIM2814C and HIM2940 were invited to attend. Faculty will post announcements to students with information to attend.
