Greetings everyone,

I hope this message finds everyone settling into some sort of a new "normal" and a work routine that is manageable given all that you have gone through in the last three weeks alone. I just wanted to try and capture some of the news from this week in one email to keep everyone as informed as possible. I normally try to save these for the end of the month, but will all that is going on, I thought a mid-month update would be helpful.

Latest Lee Campus clean-up status

Facilities is working as fast as they can to clean up and prepare Lee campus for re-opening. The goal is to be 100% back and ready for the spring semester – with L building being the biggest challenge. The VPAA's office has requested the buildings that are close to ready be opened as soon as possible for essential functions (for us that is hands-on lab classes, zoom rooms and testing centers for students, and office access for faculty). I think we are making good progress towards those possibilities over the course of the next few weeks. The Department chairs should be contacting you for specific lab requests. If you do come to campus, they are requesting all visitors limit access to specific buildings (currently A building for all your technology requests – IT will operating from there the rest of the semester) and that you use only parking lots 1 and 2 (north and south of A/AA buildings). To share the latest – most damage to campus came from the wind, and secondary

damage from broken windows which created flying glass and water damage. Nine building need roof repairs or new roofs, and they have torn down and are in the process of replacing over 50,000 ceiling tiles and over 100,000 sq. ft of dry wall. Challenges include long lead time for some supplies such as doors and windows, but they are actively working with both contractors and our insurance company to bring Lee campus back. L building was the most damaged, and in our footprint, C building is on the list for roof repairs, with H and U fairing among the very best.

Open enrollment extended to Oct 31! Everyone need to re-enroll

Hurricane Ian Relief - From HR email

Faculty and staff should apply for financial assistance funds through <u>this application</u>. Eligibility for such funds will be based on the following criteria and be determined on an objective and nondiscriminatory basis. Funds will be distributed in three (3) priority levels (applicants may receive \$\$ based on need). One per household.

H22 Updates

After much debate and back and forth, the latest guidance (which I do agree with for a variety of reasons) is that even students with a 0 for attendance verification can request the H22, but we are going with the general guidance of ending the option if they take the final exam. So if they have not participated or if they stop participating at anytime prior to the final exam, just assign a grade of H22. If they take the final exam, assign them the grade they earn, and if they fail and feel is due to current circumstances, they can petition for a late drop (under the normal procedure which requires a form and documentation). Although there might be a few who take advantage of the situation, with all that is going on in everyone's world right now, we are striving to keep education as accessible as possible to all.

Textbook relief for Students – will be the same process for the spring semester too!

Also posted as a global announcement in Canvas, many people have been working with the bookstore and publishers to replace lost textbooks and to provide free access for those moving online. If you have students now in need, please have them fill our the below form or call the bookstore number listed. Building the Spring Schedule - where we are now

I was in the process of building the spring schedule when Ian distracted me for a few weeks – I have tried my best to gather my notes and memory to submit all the requests I could for classes, dates, times and total credit hours requested and input them into the system over the course of the last three days. What you see in the system now is the **current draft** as they run the optimizer to de-conflict rooms as many, many schedules include a T/Th 10 AM class and rooms and labs get tight. I will be sending out the draft schedule to everyone in separate email next – please read the email in detail to make sure I at least have the course and modality correct as well as your requested dates and time and send me any changes required. Once the schedule comes online next week I will work in as many updates as possible and re-send with confirmed rooms, days, and times. Please bear with me on this one – I know I did not get to talk to everyone personally and I am famous for typos etc. but I think we have a good start on a spring plan. It will also be my first mail merge attempt with the schedule so keep your fingers crossed for me and don't laugh too hard if it goes terribly wrong!

Textbook Adoptions for Spring

Textbook adoptions were 1 Oct, so please work with Andy as they scramble to get the system back online and he starts the tedious input process. If you have textbook changes form fall to spring please send they to Andy ASAP. Finally, please note that the system limits us to one official textbook per campus per course, with the only exceptions being for OER or official course pilots.
