#### Job Purpose

The Simulation Operations Specialist II is responsible for coordinating and supporting simulation-based education and instructional support for AS Nursing and other Perkins-eligible health professions programs, as directed by the Associate Dean of the School of Nursing and in collaboration with program leadership and faculty from both the School of Nursing and the School of Allied Health. This role may require work at all FSW campuses but will primarily be located at one specified campus. This is a full-time, 12-month position funded by the Perkins Grant, reporting to the Associate Dean of the School of Nursing.

# **General Responsibilities**

#### **Essential Functions**

Assists with facilitating student learning experiences in the simulation environment; coordinates with faculty on didactic and laboratory courses that utilize simulation; assists faculty to ensure all students receive satisfactory programmatic and technical instruction, exposure, and experience.

Assists with the setup and takedown of the simulation supplies and equipment; maintains inventory of appropriate supplies, patient forms, and equipment at clinical and/or laboratory training sites.

Assists the faculty, instructional staff, and program leadership with maintaining simulation education records, including outcome measures such as student learning in simulation experiences, as well as performance measures in the educational delivery of simulation/practicum education.

Provides technical support for all simulation operations, including preparation, maintenance, and repair of computerized manikins (software and hardware), task trainers, and related multimedia peripherals.

Ensures the effective and efficient operation of the lab, assesses and provides for meeting program and student needs, and oversees the operation of high and medium fidelity technology to ensure safe and effective use of the simulation equipment.

#### SIMULATION OPERATIONS SPECIALIST II, SCHOOL OF NURSING

Coordinates activities in the pre-clinical, clinical, laboratory, and in simulation education settings as determined appropriate by program faculty and instructional staff.

Performs as a liaison with external agencies used for simulation and continuing educational experiences.

Supports/assists in role playing applications, props placement, and moulage setup to create a virtual health care environment and experience.

Operates simulators based on priorities identified by the faculty and instructional staff.

Assists with training faculty and instructional staff in the use of simulation equipment.

Conducts tours and simulation sessions for internal/external groups and/or individuals.

Assists faculty, instructional staff, and program leadership in developing new courses or training initiatives.

Engages in educational endeavors to maintain proficiency with simulation technology and its use to facilitate learning.

Monitors cost-effective use of human and material resources.

Assists with implementation of simulation that aligns with an assigned course(s) or program according to the curriculum, program accreditation standards, and the course and program objectives as assigned by program leadership.

Assists in ensuring that simulation standards of best practice are followed.

Participates in departmental, committee, and other College meetings; attends local, state, and regional meetings as appropriate to support the development of assigned programs.

Assists and helps to organize Open Labs.

Contributes additional instructional support services, as assigned.

Performs other duties as assigned.

These essential job functions are not to be construed as a complete statement of all duties performed; employees will be required to perform other job-related duties as required. Registered Nurse with a relevant Bachelor's degree or higher degree from a regionally accredited institution of higher education.

Three (3) years of professional full-time work experience in nursing or related healthcare discipline.

Current unencumbered licensure in good standing as a registered nurse.

Encouraged to obtain Certified Healthcare Simulation Operations Specialist certification within eighteen (18) months of hire.

Must be able to work flexible schedule that may include evening and weekend assignments.

This is a campus-based position with occasional travel to other campuses for official FSW business as needed to assist with simulation.

Demonstrated experience using instructional technology, computers, and software applications.
