7. Software/Canvas LTI apps Request Form Process (Laura/Jason)

- a. [Software Request Form](#) (For software/instructional technology not integrated into Canvas)
 - i. Requires: justification, description, campus location, funding source
 - ii. Vetting requirements: accessibility, data security, FERPA compliance, legal review
 - iii. FSW Online campus designation will be added to form
- b. [Canvas LTI Request Form](#) (For external tools integrated into Canvas)
 - i. Vetting requirements: accessibility, data security, FERPA compliance, legal review
 - ii. List of approved LTIs available on Canvas LTI form
- c. Some need to know:
 - i. Submitting a request does not mean guaranteed approval
 - ii. Currently, departments fund individual software subscriptions
 - iii. No IT budget line exists yet for faculty ed tech software subscriptions
 - iv. Subscription services cannot auto-renew; annual reapplication will be required
 - v. Vetting process will check for redundancy with existing enterprise licenses

 - i. Most of the current AI detection software are not very reliable
 - ii. Here are 2 applications that FSW has for writing papers
 - 1. PackBack Deep Dives
 - a. April Ring is piloting this semester

- b. Features "Originality Footprint" assessment before submission
 - c. Proactive rather than punitive approach
 - d. Alisa Callahan confirmed positive prior experience with a minimum originality score requirement
- 2. Grammarly Authorship
 - a. Works with Google Docs with the Grammarly Google extension enabled
 - b. Provides shareable reports and replay functionality
- b. Jessica shared that there is a broken link on FSW Knowledge Base article for obtaining written student consent
 - i. Roz fixed the broken link
 - ii. Contact Dr. Brenda Knight (Registrar's Office) for official/more FERPA guidance
- c. Roz - Class Technologies
 - i. Class contract expires 4/29/2026
- d. Virtual Classroom Standards and COP Updates
 - i. [Current Standards for Virtual Classrooms webpage](#) created 2020 will be removed
 - 1. References outdated COPs (last updated 2015 and 2019)
 - a. ATC charged with updating the following COP's then Academic Standards Committee will review
 - i. COP 03-0609 - Privacy and Classroom Attendance
 - 1. Currently only addresses traditional in-person classes
 - 2. Needs consideration of students attending from home (FERPA implications if others are present)
 - 3. Must account for all current modalities
 - ii. COP 03-0614 - Recording of Classes
 - 1. Currently addresses recording for disability accommodations
 - 2. Incorporate 2021 Florida statute allowing student recording under certain circumstances
 - 3. Needs broader context for recording scenarios
 - ii. New resources will be created to replace the webpage:
 - 1. Relevant faculty-facing content will be added to the FSW Online Handbook section on best practices for virtual classroom management, including links to relevant COPs

2. Student-facing content will be added to a new Canvas page
 - a. Available in Live Online/Flex templates
 - b. Shareable via Canvas Commons
 - c. Will include appropriate behavior expectations (dress code, no smoking/vaping, etc. per Jaime Lynn Zlatkin's suggestion)
