- III. E-Learning Committee is now officially an Academic Standing Committee.
 - a. Representation on the committee is designed to encourage participation from all schools and divisions across the college (not just campuses).
 - b. The e Learning Committee scope of responsibilities and membership was ratified by the committee members.
 - c. Members may serve two year terms.
 - d. The idea that all members will roll off the committee simultaneously will be evaluated in the future.
