## **Spring Early Alert Submissions**

Whitney welcomed the group and started the meeting by reviewing the current spring semester Early Alert submissions. To date, we have received 855 alerts college-wide. The number of Early Alert submissions is more than the previous fall semester. During the fall term, we received 622 alerts college-wide. The increase of alerts submitted during the fall semester over the spring semester seems unique because fall is typically a larger semester with more students. One reasons for the influx could be due to the

superior service provided by the early alert representatives, the ease of use regarding the new submission process, the placement changes due to SB 1720, or a combination. Susan inquired about the number of students who were alerted in gateway classes specifically ENC 1101 and MAT 1033. Monica mentioned the number of students visiting the Tutor Center has not increased. Kim noted that the number of students using tutor.com has increased.

## **3C Program**

Monica Moore introduced a new program at Edison called 3C= College Community

Collaboration. The program is in partnership with the Gulf Coast Literacy Council.

Volunteers help EAP and 2<sup>nd</sup> language students with vocabulary and articulating. The program was started this fall and is looking to be continued. Attached, please find a flyer regarding the program.

## **Review of Early Alert Submission Questions**

The group reviewed the current Early Alert submission form and identified the following suggested changes:

- Student has never attended class selection for question one
- Addition of week 1-3 drop down and week 4-6 drop down, etc.
- Question regarding if the professor accepts late work / resubmissions, or gives extra credit
- A question regarding if the student has the opportunity to catch up / be successful in the course

- The addition of unknown as a selection for the question does the student exhibit a willingness to improve academic performance
- Adding a line to the question relating to medical issues, asking the professor if the student has been referred to Student Services
- Adding a question regarding what actions the professor would like the EA representative to take.
- Deleting some of the repetitive metrics in the 2<sup>nd</sup> question regarding students student habitats.

#### **Student Success Discussion**

The group entered into discussion about students who are not succeeding and if there are any ramifications. Susan noted that once a student has a GPA below 2.0, they are identified as being on Academic Warning and are limited to 12 credit hours. If their GPA continued to diminish the student will be placed on Academic Probation and limited to 9 credit hours. The group talked about rehabilitation efforts for the student through required student success workshops for students who have not been successful focusing on time management, study skills, note taking, etc. The group also talked about how this may be less of a problem once all students are required to take SLS 1515 since they will all be learning those success skills in their Cornerstone Experience course.

#### **Fall Semester Student Success Results**

Whitney reviewed the Lee campus fall semester student success results which are below. Whitney noted that over 50% of the students who were alerted persisted to the following semester. College-wide success data will be provided to the group via email.
