- II. Canvas update (Anderson)
  - a. Approximately 80% of online courses have been migrated to Canvas
  - b. The majority of online instructors are now certified to teach with Canvas
  - c. Ground instructors started training during the summer
  - d. Software updates discussed
- III. Discussion of COP 03-0805 General Course Operating Procedures
  - a. Specifics were deleted from document and incorporated into Edison Online Guidelines
  - b. Edison Online Guidelines need to be vetted through the eLearning Committee
  - c. Guidelines were discussed regarding attendance verification, professor introduction videos/media, communication response time and grading
  - d. Conversation needs to continue regarding the COP
- IV. Discussion of best practices in online learning
  - a. Videos should have corresponding transcripts
  - b. Instructors need to have presence in the classroom
  - c. Syllabi should clearly state grading policy
- V. Discussion of Master Courses
  - a. Core part should not be modified
  - b. Core part reflects learning outcomes specified in the syllabus
  - c. Can the core part be locked down?
  - d. Data is relevant as long as the core remains intact.
  - e. Need to discuss further



- VI. Proctored Exams
  - a. Academic departments need to have input into policies regard proctored exams
  - b. Academic departments should work with Edison Online to establish guidelines
  - c. It was suggested that lower level general education courses be proctored (Anderson)
