- I. Meeting minutes approved for 02-28-2013
- II. Updates TLC Rudy Moreira
 - Data has been collected and analyzed from Fall 2012 Cornerstone Modules evaluations
 using SPOL (Strategic Planning On-Line) the results indicates all modules received
 higher ratings than the projected score
 - b. The projected overall score was set at 85% and the modules as a unit received 91%
 (actual) this indicates that the modules are being well received by attendees and evaluated as beneficial and effective
 - c. Specific module data is listed below: Each measures effectiveness score is a weighted score based on a projected score. The benchmark for this weighted score is based on a projected score that at least 85% of respondents to workshop survey, would rate each element of a workshop category as good to excellent. The categories include content, presentation and overall workshop rating. At the program level the Cornerstone Experience Training Modules' effectiveness rating is 110%.

- d. Evaluation results and presenter feedback all agree that the Critical Thinking module is the most difficult one to present and be effective, all are in agreement that it is an essential piece of the QEP / FYE program and will continue to be redeveloped
- e. Suggestion was made to tailor the Critical Thinking modules towards specific groups (counselors, advisors, education faculty, business faculty, tech programs) in the future this could improve the effectiveness of the module and make it more meaningful and useful for faculty
- f. The Webinars offered in the Fall 2012 semester were also successful additional webinars are in discussion providing funding, staff, resources can be obtained QEP Overview & Objectives Webinar 118%, QEP Assignments & Assessments Webinar 117%
