FINANCIAL AID DEADLINE:

Please be advised that there will be an add/drop deadline for all students who wish to receive financial aid assistance during the Spring 2017 semester. As of January 11, 2017 all students must have enrolled credits in order to "lock" their financial aid package for the term. This means all classes (including A, B, and full term) must be registered for and enrolled in by the deadline in order to receive financial aid.

SAP APPEALS

Students who have circumstances that prevent them from meeting Satisfactory Academic Progress (SAP) during the semester in which they are enrolled have the right to appeal their Financial Aid eligibility. Updated appeal forms are available now: <u>www.fsw.edu/financialaid/forms</u>
