- 1. Follow-up on Campus Leadership Discussion
  - a. Drs. McClinton and Teed met with Amanda Lehrian (Director, Hendry/Glades Center) to review and discuss scheduling; Charlotte Campus will be next; Collier Campus is okay
  - b. Upcoming opportunity with Florida Gulf Coast University may help with the low enrollment at Charlotte
- 2. 5-Year Course Deletion
  - a. Deans need to send the list of courses to Dr. DeLuca as soon as possible
  - b. Courses that are scheduled for deletion but are being kept probably need to go through Curriculum Committee for revising and updating
- 3. SACSCOC Update
  - a. The update information presented at the August 15<sup>th</sup> Provost's meeting was reviewed
  - b. CR 8.1 (formerly FR 4.1): need to convene program leaders and discuss how the goals were developed and develop goals for the future
  - c. CS 8.2.a (formerly CS 3.3.1.1): we will work with all people that have access to Compliance Assist and provide training on language, how to use the results, how do you do the process
  - d. Dr. van Gaalen and Barbara Miley are working with unit leaders on writing their 2017-2018 effectiveness plans correctly since the plans will be submitted with the SACSCOC Monitoring Report as evidence of compliance and good faith towards best practices for effectiveness plans.
- 4. BAS/IST Update
  - a. The potential for this degree is being revisited
  - b. Dr. DeLuca met with FGCU's provost and discussions with FGCU's Lutgert College of Business are indefinitely on hold



- c. It is hopeful that discussions will continue in the future
- d. FGCU's provost and president are in full support of the proposed degree
- 5. MOU with FGCU
  - a. Portions of the draft language was reviewed
  - b. MOU will enhance existing relationship and make it more robust
  - c. Discussions are taking into consideration allowing students to reverse transfer
- 6. Civics Literacy (Dr. Wright)
  - a. It is important to better understand what "first time in college" means (language from new Florida Civic Literacy Competency Rule).
- 7. Other Business
  - a. International Education has some exciting plans for the future
  - b. Five faculty members will be leading classes to Lorenzo de Medici School (LDM) next summer; students will take one class from LDM and one from FSW
  - c. Need to include FGCU in discussions for their students

o FGCU Scholarship for FSW Collegiate High School Graduates

The Parties will be proactive in our joint efforts to provide a pathway to FGCU bachelor's degree completion for students graduating from FSW Collegiate High Schools. The Parties will establish a related scholarship program.

o Program Marketing

This agreement provides that both Parties can market the program as a cooperative partnership between FGCU and FSW.
