1. Review SACSCOC Update

- a. The institution was notified in July of the need for a Monitoring Report related to FR 4.1 and CS 3.3.1.1
- b. Dr. van Gaalen provided a review of Compliance Assist
 - The 2017-2018 General Education Effectiveness Plan was reviewed for best practices and components
 - ii. It is very important to link 2017-2018 plans to 2018-2019 plans
 - iii. Key to reporting results of goals is to have meeting minutes or notes
 - iv. Goals do not necessarily have to be met for the process to be considered effective/successful; the key is to set goals, assess, review and analyze, and then determine how the results will be used

2. Discuss 8.2a (SACSCOC Principle)

- a. "For each of its educational programs, the institution a. Justified and documents the qualifications of its faculty members. (Faculty qualifications)"
- b. It is important to understand the principle as we begin to prepare for reaffirmation in 2022
- c. It is also important to demonstrate we have an adequate number of full-time faculty and then make the case for compliance
- d. The narrative will also need to document any supervisory roles of full-time faculty
- e. Deans need to start thinking about where the faculty shortages are occurring and move staffing requests forward



3. Discuss CAN 8.15 and 8.5

- a. 8.1.5F is very important in the faculty hiring process; deans will make the final decision in determining a faculty member's teaching schedule
- b. 8.5 when thinking about relocating faculty, deans need to think in terms of relocating from the Lee campus to other campuses (not vice versa)
- c. Staffing for the Clewiston Collegiate Institute was reviewed and we are committed to hiring the faculty to staff the classes
- d. Dr. McClinton and Dr. Teed are ultimately responsible for AA staffing and scheduling
- e. Dr. DeLuca is committed to lobbying for staffing faculty needs
- f. Faculty that are being interviewed need to interview on the prospective campus and need to meet campus leaders
