Scott Gregory from McGriff Insurance Services, Inc. spoke about the forthcoming merger between BB&T and SunTrust. The new entity which will be the nation's sixth largest bank will be known as Truist Financial. McGriff Insurance provides the general liability, excess liability, commercial flood, excess flood, crime, blanket accident, and directors and officers liability insurance for the Financing Corporation. McGriff has been with the Financing Corporation since 2011. Scott Gregory reviewed the coverage limits for each of the above listed coverages with the Board.

Mark Lupe spoke about the College owned property located at 6121 Winkler Road. This property while close to the Lee Campus is not contiguous to the Lee Campus. This property is zoned as central urban land use which is different from the rest of the Lee Campus which is zoned public facilities. The development of the property must be consistent with the zoning. The central urban land use zoning does include the right to use the property for an educational use. Educational use would not include creating a parking lot for tour buses and semi-tractor trailers, but would include athletic fields. The improvements discussed at the March 26, 2019, meeting would need to take place should the College choose to develop the parcel.

President Allbritten and Gina Doeble spoke on the status of the BB Mann piano. The Piano underwent restorations and now is back and is in top form.

Kathleen Porter reviewed the first quarter financial statements with the Board.

Mrs. Mann thanked President Allbritten and Gina Doeble for their quick response on her question about the BB Mann piano.
