We have several students who have successfully completed all of the required coursework for our program including a 250-hour residency; however, they have been unable to fulfill the Math requirement despite numerous attempts to do so. College level math is not a requirement for students to be successful in the field of Social and Human Services and is not required by the Florida Department of Education or SACS at this time. We are proposing giving students the option of choosing Math or Natural Sciences to fulfill their General Education requirements in the FSW Social and Human Services Program. The Natural Science requirement would be reduced from 4 credits with a lab to 3 credits. This credit change would be offset by increasing HUS 2905 from 2 credits to 3 credits.



This course will provide an in-depth review of a broad spectrum of psychopathological disorders as defined by the DSM-5 (2013). CLP 2140 examines the theoretical perspectives and current research as it relates to abnormal behavior with primary emphasis on identifying the symptomatology, etiology and effective treatments of various mental disorders, which include depressive disorders, anxiety-related disorders, stress and trauma disorders, addictions, eating disorders, schizophrenia, and more.

Section III, Justification for proposal

This new course proposal corrects an error in the course prefix and number for **Abnormal Psychology** [PSY 2146]. State Course Numbering System (SCNS) does not include PSY 2146 as an option for *Abnormal Psychology*; PSY was mistakenly substituted for CLP on original New Course Proposal dated 10/1/2018. State recommends changing the course number. After further research in SCNS, CLP 2140 is the most appropriate number, meeting Psychology program objectives as a lower-level course with a prerequisite of PSY 2012. CLP 2140 is the most-commonly used course prefix and number among Florida colleges and universities for *Abnormal Psychology*, making transfer more straightforward.

There is continuing demand for a course in Abnormal Psychology at FSW. The "mental health matters" initiative has been bolstered by student involvement in chartering an Active Minds chapter at FSW. This student organization focuses on mental health awareness and suicide prevention efforts.

The number of college students seeking careers in healthcare, education, or the human services (e.g., psychology, social work, criminology) is on the rise. According to the National Institute of Mental Health (NIMH), 49.5% of children and adolescents meet the criteria for a mental disorder while 57% of adults will carry a Diagnostic and Statistical Manual of Mental Disorders (DSM-5, 2013) diagnosis at some point in their lives (NIMH, 2016). Mental illness can be debilitating, affecting individuals and their families socially, educationally, physically, and financially. Therefore, any student choosing a course of study in the helping professions will benefit from learning the etiology, prevalence, incidence, and treatment of mental disorders.
