Summary:			
Change title to <i>Fundamentals of Communication Studies</i> to reflect new department name and breadth of coverage, and to reduce confusion with SPC 2608 <i>Introduction to Public Speaking</i> .			
Delete prerequisite course ENC 1101 to open enrollment to first-semester students, thereby adding flexibility to student and faculty schedules. SPC 1017 and ENC 1101 share some CLOs but approach them in different ways, so are complementary and do not need to be taken in a fixed order.			
For the CC meeting, refer to syllabus with title ending, "Updated 9-24-21," which includes tracked changes consistent with (only) the current proposal, having removed those presented Sept. 3.
