Job Title: Science Lab Manager II Pay Grade: 111

Job Code: 4167 FLSA Status: Exempt

Job Purpose

This position is responsible for professional, technical work in providing supervision and instructional support in the science laboratories for a designated campus within the School of Pure and Applied Sciences. Lab supervision includes, but may not be limited to, anatomy and physiology, biology, chemistry, microbiology, and physics laboratories. The Science Lab Manager II also supports the lab courses within the prescribed curriculum for students enrolled at the College by helping to prepare and design labs in support of the laboratory courses, as well as provide support to instructors within the School of Pure and Applied Science conducting research.

General Responsibilities

Essential Functions

Maintains laboratories for instruction of students, to include preparing chemical solutions and microbiological media, maintaining bacterial cultures and other living organisms, and properly disposing of chemical and biological wastes. Laboratory maintenance includes stocking/ordering supplies, arranging for equipment repairs and maintenance, and keeping the labs neat and orderly. Contacts cleaning, maintenance, and technology support supervisors to ensure that the laboratories are clean and functioning well.

Orients new faculty to the resources, offerings, equipment, and materials available in the labs. Supports new faculty in developing laboratory curriculum and delivering instruction.

Maintains inventories of chemicals and equipment, researches and obtains price quotes, and prepares purchase orders for lab supplies as needed. Maintains budget records, proposals, budget initiatives, and provides necessary input for budget justifications.

Provides instructional design support to laboratory courses as assigned by the Dean, School of Pure and Applied Sciences according to the needs of the College. Courses designed are in accordance with the course description as outlined in the College Catalog, course syllabus, and other approved curricular materials.

Completes and submits special reports as required by the College.

SCIENCE LAB MANAGER II

Maintains S.D.S. (Safety Data Sheets) and ensures compliance with safety regulations of science laboratories.

Collaborates with Program Coordinators and faculty to ensure that science lab instruction is coordinated, and that all students receive adequate lab instruction, exposure to skills, and skill experience. Contributes to the academic offerings at the campus by providing specialized guidance and resources in the development of relevant laboratory curriculum.

Provides consultative services to regular and adjunct faculty on the content and design of laboratory exercises in support of the prescribed curriculum.

Supports and guides lab students who are learning to operate laboratory equipment and learning to perform skills during scheduled laboratory classes in conjunction with faculty. Attends classes and serves as laboratory assistant, as needed by the faculty member.

Supervises students working as lab assistants and faculty research assistants.

Assists faculty with lab support for research projects as requested.

Performs required institutional functions, such as serving on College committees, attending meetings, etc., as assigned.

Performs other duties as assigned.

These essential job functions are not to be construed as a complete statement of all duties performed; employees will be required to perform other job-related duties as required. An employee with a disability is encouraged to contact the Human Resources Office to evaluate the job in greater detail in order to determine if she/he can perform the essential functions of this job with or without reasonable accommodation.

Knowledge, Skills and Abilities

Minimum Qualifications

Master's degree from a regionally accredited institution of higher education discipline in biology, anatomy and physiology, chemistry or related appropriate science discipline

Three (3) years of experience working in a laboratory.

Demonstrated history, or evidence, of an interest in professional development activities, which may include research, additional coursework, seminars, and conferences, etc.

Knowledge of the equipment, materials, software, hardware, chemicals, attesting instruments, etc., that are appropriate to the laboratories assigned.

Knowledge of potential laboratory hazards, precautionary measures and appropriate safety procedures.

Demonstrated experience using a personal computer, office software such as MS Office and electronic mail.

- Collaborate and be effective working with diverse populations.
